



ORDINANCE NO. 2985

AN ORDINANCE OF THE CITY OF LYNNWOOD, WASHINGTON, RELATING TO THE PERSONNEL BENEFIT OF FREE USE OF THE RECREATION CENTER FOR REGULAR EMPLOYEES; ADDING A NEW SECTION 2.50.051 TO THE LYNNWOOD MUNICIPAL CODE; AND PROVIDING FOR SEVERABILITY, AN EFFECTIVE DATE AND SUMMARY PUBLICATION.

WHEREAS, Lynnwood Municipal Code provides certain Personnel Benefits for employees set forth in Chapter 2.50 of the code; and

WHEREAS, the City of Lynnwood has for several years provided employees with free use of the recreation center as a personnel benefit in support of wellness and workplace productivity; and

WHEREAS, the City of Lynnwood deems it appropriate to clarify and memorialize this personnel benefit in Lynnwood Municipal Code;

THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. A new Section 2.50.051 is added to the Lynnwood Municipal Code to read as follows:

Regular full time and regular part time employees may use the City's recreation center facilities at no charge under the following conditions:

- A. an Employee's use of the recreation center will not be considered time worked unless specifically provided for in a policy or collective bargaining agreement, and
- B. employees will pay the full fee for participation in certain programs such as those provided by contractual instructors or other programs as determined by the Director of Parks, Recreation and Cultural Arts.

Section 2. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3. This ordinance or a summary thereof consisting of the title shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after publication.


