



**ORDINANCE NO. 3043**

**AN ORDINANCE OF THE CITY OF LYNNWOOD, WASHINGTON, AMENDING ESTABLISHED FEES AND CHARGES FOR THE 2013-2014 BIENNIUM AND REPEALING CURRENT FEES AND CHARGES; PROVIDING FOR SEVERABILITY; ESTABLISHING AN EFFECTIVE DATE; AND PROVIDING FOR SUMMARY PUBLICATION.**

WHEREAS, the City Council desires to establish fees and charges for the 2013-2014 biennium, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The fees and charges set forth on Attachment A are established as City of Lynnwood fees and charges for the 2013-2014 biennium.

Section 2. The fees and charges imposed by Title 3.104.010 of the Lynnwood Municipal Code are hereby amended.

Section 3. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 4. This ordinance or a summary thereof consisting of the title shall be published in the official newspaper of the City, and shall take effect and be in full force January 1, 2014.


Section 5. The fees and charges set forth herein may be amended by resolution or motion at any time by the City Council.





