



ORDINANCE NO. 3074

AN ORDINANCE OF THE CITY OF LYNNWOOD, WASHINGTON, ESTABLISHING ADDITIONAL PROJECT FUNDING FOR CONSTRUCTION OF ANCILLARY INFRASTRUCTURE NECESSARY TO THE INTERURBAN TRAIL 208TH STREET SW CROSSING IMPROVEMENTS ALONG 208TH STREET SW BETWEEN 52ND AVENUE W AND 54TH AVENUE W; AND SUPERSEDING ORDINANCE 3059; AND AUTHORIZING EXPENDITURES IN PROJECT FUND 350; AND AUTHORIZING FUNDING TRANSFERS, ALLOCATIONS, AND REIMBURSEMENTS FROM FUND 411; AND CONSISTENT WITH THE PROJECT FINANCIAL PLAN; AND PROVIDING FOR SEVERABILITY, AN EFFECTIVE DATE AND SUMMARY PUBLICATION.

WHEREAS, pursuant to Chapter 35A.33 RCW, the City of Lynnwood is required to appropriate funds for City projects and to formally authorize the transfer of appropriations from one fund to another fund; and

WHEREAS, the City is committed to a planned transportation and traffic improvement program as a part of the City Transportation Program and Capital Facilities Plan; and

WHEREAS, construction of the Interurban Trail missing links segments (hereinafter "Project") is included in the City's Capital Facilities plan as project number PK1998021A; and

WHEREAS, this existing segment of the Interurban Trail utilizes bike lanes inside the curb lines, and adjacent 5-foot sidewalks, which do not meet current design/safety standards; and

WHEREAS, the City has established funding from fund 411 and fund 331 to rebuild this missing link segment of the interurban trail, from 52nd Avenue W to 54th Avenue W, adjacent to 208th Street SW; and

WHEREAS, the City has been awarded a \$544,000 Federal Enhancement grant for the design and construction phases of the Project; and

WHEREAS, the construction of these improvements require the installation of a stormwater detention facility to mitigate the addition of new impervious surfaces; and

WHEREAS, the City had expected to install the necessary stormwater detention as a part of the 53rd Avenue West Improvements Project, but that project will not be constructed in a timeframe acceptable to the Federal granting agency, thereby requiring the installation as an additional change order to the current contract, and

WHEREAS, the City previously approved a Project financial plan in Ordinance 2903, and

WHEREAS, the City previously approved a Construction financial plan in Ordinance 3059;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Appropriation:




