



ORDINANCE NO. 3097

**AN ORDINANCE OF THE CITY OF LYNNWOOD, WASHINGTON,
ADOPTING MODIFICATIONS TO THE 2013-2014 BUDGET;
PROVIDING FOR TRANSMITTAL OF THE BUDGET MODIFICATION
TO THE STATE; AND PROVIDING FOR SEVERABILITY, AN
EFFECTIVE DATE AND SUMMARY PUBLICATION.**

WHEREAS, on December 12, 2012, by Ordinance No. 2974, the City Council of the City of Lynnwood adopted a biennial budget for the years 2013-2014; and

WHEREAS, on March 26, 2013, by Ordinance No. 2981, the City Council of the City of Lynnwood adopted modifications to the biennial budget for the years 2013-2014; and

WHEREAS, on June 9, 2013, by Ordinance No. 3065, the City Council of the City of Lynnwood adopted modifications to the biennial budget for the years 2013-2014; and

WHEREAS, on December 12, 2013, by Ordinance No. 3036, the City Council of the City of Lynnwood adopted modifications to the biennial budget for the years 2013-2014; and

WHEREAS, on July 14, 2014, by Ordinance No. 3070, the City Council of the City of Lynnwood adopted modifications to the biennial budget for the years 2013-2014; and

WHEREAS, on August 11, 2014, by Ordinance No. 3080, the City Council of the city of Lynnwood adopted modifications to the biennial budget for the years 2013-2014; and

WHEREAS, the City's Administration recommends a revision to the 2013-2014 budget to provide budget authority from the Restricted Fund Balance to provide for a final payment distribution as a result of the amendment to the termination of the agreement to operate the Lynnwood High School Athletic Complex; now, therefore

THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Modification of the 2013-2014 Biennial Budget. The required expenditures for operation of the various departments and funds of the City of Lynnwood for the fiscal years ending December 31, 2013 and 2014, are hereby modified and amended as shown in **Exhibit A**


attached hereto and incorporated herein. A complete copy of this ordinance shall be transmitted to the state auditor and to the Association of Washington Cities.

Section 2. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3. Effective Date and Summary Publication. This ordinance or a summary thereof consisting of the title shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after publication.
