**ORDINANCE NO. 3100**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, RELATING TO THE POSITION OF ADMINISTRATIVE ASSISTANT TO THE CITY COUNCIL; AUTHORIZING A STEP INCREASE IN BASE HOURLY WAGES; AND PROVIDING FOR SEVERABILITY, AN EFFECTIVE DATE, AND SUMMARY PUBLICATION.**

WHEREAS, the City Council is authorized by RCW 35A.11.020 to adopt ordinances relating to municipal affairs and appropriate for the effective and efficient government of the City, to provide for necessary employees, to define the functions, powers, and duties of City employees, and to provide for the compensation and working conditions for the various City employee positions; and

WHEREAS, in Ordinance No. 2608, codified at LMC 2.04.080 et seq., as amended, the City Council created the position of Administrative Assistant to the City Council, and established terms and conditions for that position; and

WHEREAS, LMC 2.04.090 provides that the Administrative Assistant to the City Council shall receive compensation in such amounts as the Council may establish from time to time by ordinance; provided, that the Administrative Assistant shall receive annual cost of living adjustments at the same time and at the same rate that such adjustments are given to other unrepresented employees of the City; and

WHEREAS, the Administrative Assistant last received a step increase in wages effective January 1, 2010, pursuant to Ordinance No. 2808; and

WHEREAS, the City Council has determined that in addition to the cost of living adjustment authorized by LMC 2.04.090, it is appropriate to increase the hourly wage of the Administrative Assistant for the 2015-16 budget period, in an amount equivalent to one step increase for other unrepresented City employees, which is four percent;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1.** The base hourly wage of the employee currently employed as the Administrative Assistant shall be increased by \$1.10 per hour, which is four percent of the Administrative Assistant's current hourly wage.

**Section 2.** In addition to the wage increase authorized in Section 1 above, and consistent with LMC 2.04.090, for each of the years 2015 and 2016 the Administrative Assistant shall receive annual cost of living adjustments at the same time and at the same rate that such adjustments are given to other unrepresented employees of the City.


**Section 3.** Severability. If any section, subsection, sentence, clause, phrase or word of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality thereof shall not affect the validity or constitutionality of any other section, subsection, sentence, clause, phrase or word of this Ordinance.

**Section 4.** Effective Date. This Ordinance shall take effect and be in force five days after its passage and publication.

**Section 5.** Summary Publication. Publication of this Ordinance shall be by summary publication consisting of the ordinance title.


