**ORDINANCE NO. 3114**

**AN ORDINANCE OF THE CITY OF LYNNWOOD, WASHINGTON, ESTABLISHING PRE-DESIGN FUNDING FOR THE 194<sup>TH</sup> STREET SW EXTENSION IMPROVEMENT PROJECT; AN ORDINANCE AUTHORIZING EXPENDITURES IN PROJECT FUND 310; AND AUTHORIZING FUNDING TRANSFERS, ALLOCATIONS, AND REIMBURSEMENTS FROM FUND 110; AND CONSISTENT WITH THE PROJECT FINANCIAL PLAN; AND PROVIDING FOR SEVERABILITY, AN EFFECTIVE DATE AND SUMMARY PUBLICATION.**

WHEREAS, pursuant to Chapter 35A.33 RCW, the City of Lynnwood is required to appropriate funds for City projects and to formally authorize the transfer of appropriations from one fund to another fund; and

WHEREAS, the City is committed to a planned transportation and traffic improvement program as a part of the City's Transportation Improvement Program and Capital Facilities Plan; and

WHEREAS, the 194<sup>th</sup> Street SW Extension Project from 40<sup>th</sup> Avenue W to 33<sup>rd</sup> Avenue W (hereinafter "Project") is included in the City's Capital Facilities Plan as project number 200900101; and

WHEREAS, the Project will provide traffic relief to 196<sup>th</sup> Street SW by providing a new connection between the City Center and Alderwood Mall area, improve internal City Center circulation, provide for and encourage pedestrian traffic and enhance access to the adjacent properties; and

WHEREAS, \$150,000 is available in Traffic Impact Fee Fund 110 to complete the pre-design study for the Project;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, DO ORDAIN AS FOLLOWS:

**Section 1. Appropriation:**
