



ORDINANCE NO. 3121

AN ORDINANCE OF THE CITY OF LYNNWOOD, WASHINGTON, RELATING TO COMPENSATION FOR CITY EMPLOYEES; AMENDING SECTIONS 2.48.175 AND 2.48.185 OF THE LYNNWOOD MUNICIPAL CODE; AND PROVIDING FOR SEVERABILITY, AN EFFECTIVE DATE AND FOR SUMMARY PUBLICATION.

WHEREAS, the City Council of the City of Lynnwood has authority to create and delete employee positions in the City, and to establish and amend pay grade classifications and compensation amounts for employee positions in the City; and

WHEREAS, in LMC 2.48.175, the City Council has established a basic pay plan for certain City employees based on pay grade classifications; and

WHEREAS, in LMC 2.48.185, the City Council established pay grade classifications for certain employee positions in the City; and

WHEREAS, the City Council has determined that it is appropriate and in the best interests of the City to amend LMC 2.48.185 (1) to add a new department titled Information Services and (2) add the classification of Information Services Director, pay grade 625 and (3) move the titles of Applications Supervisor, pay grade 622, Network Supervisor, pay grade 622 and Operations Supervisor, pay grade 622 from the Administrative Services Department and place them in under the new department title of Information Services and (4) remove the position of Assistant Finance Director – Information Services, pay grade 625 as a result of departmental restructuring of Administrative Services; now, therefore

THE CITY COUNCIL OF THE CITY OF LYNNWOOD, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Section 2.48.185 of the Lynnwood Municipal Code is amended to read as follows:

2.48.185 Pay grade classification.

The following shall be the pay grades in the basic pay plan set forth in LMC 2.48.175, assigned to the appropriate position:






