
WHEREAS, the City Council has determined that adoption of an annual calendar of meetings for the council will help in the orderly and expeditious conduct of Council and City business; now therefore


Section 2. The City Council retains its discretion to make other scheduling changes during 2011 as it deems necessary and appropriate.
