

JOINT INTERLOCAL PURCHASING AGREEMENT

1. Parties. The parties to this agreement are the City of Arlington, a municipal corporation of the State of Washington (hereinafter "Arlington"), and the City of Lynnwood, a municipal corporation of the State of Washington (hereinafter "Lynnwood").

2. Purpose. The purpose of this agreement is to provide for the purchase of equipment through use of bids and bid specifications.

3. Duration. This agreement shall be effective for a period of two years, commencing as of the date of execution of this agreement, unless sooner terminated by either party.


4. Authority. Each party is authorized to utilize bids and bid specifications prepared by the other for purposes of equipment purchases, when deemed appropriate by the respective Public Works directors or other department heads. Each party shall notify the other in advance of its desire to use bids or bid specifications and shall obtain the consent of the other, which consent shall not unreasonably be withheld.

5. Termination. This agreement may be terminated by either party without cause upon 30 days' prior written notice to the other party.






