

COOPERATIVE PURCHASING AGREEMENT

Skagit County

This agreement is made and entered into this 27 day of December, 2004 between the City of Lynnwood ("City") and the Dike District #17 ("joining agency.") Pursuant to 39.34, the Interlocal Cooperation Act, the parties agree to a cooperative purchasing agreement: (1) various supplies, materials, equipment and services, using the City's competitively awarded contracts (2) using a Shared Small Works Roster for a list of eligible public work contractors; and (3) choice to participate in the Shared Architects and Engineering Roster. Each of these three are available at the choice and option of the participating agency. Such use is not mandatory and no implication of mandatory use is intended through signature of this agreement, but instead this agreement is to allow participating agencies the ability to share such services upon occasion and at such time as benefits the participating agencies. The parties agree to the following:

Supplies, materials, equipment and services

1. Each agency, in contracting for the purchase of supplies, materials, equipment and services, agrees at its discretion, to extend contracts for shared use to the extent permitted by law, and agreed upon by these parties and the vendor(s).
2. Each agency is independently responsible for compliance with any additional or varying laws and regulations governing purchases.
3. Any purchases shall be effected by a purchase order from the purchasing agency and directed to the vendor(s).
4. The originating contracting agency does not accept responsibility or liability for the performance of any vendor used by the purchasing agency as a result of this Agreement.
5. Each agency shall be independently responsible for payment of any item(s) purchased through a contract or purchase order that resulted from this Agreement.

Shared Small Works Roster

6. The City of Lynnwood is the lead agency.
7. The joining agency shall express an intent to the City of Lynnwood, to utilize the Shared Small Works Roster. Such expressed intent does not impose a mandatory or continuous use of the Roster, but simply establishes the eligibility to use the Roster upon the convenience and interest of the joining agency. This interest may be expressed to Lynnwood at any time.
8. The joining agency may use the Shared Small Works Roster that has been established and maintained by the City of Lynnwood, to select contractors for public work jobs up to \$200,000 in value or as otherwise limited by ordinance or law. The Shared Small Works Roster has been established for shared use by the City of Lynnwood and other public agencies.
9. The City of Lynnwood and the joining agency named herein shall each be independently responsible for their own and the contractor's compliance with all additional or varying laws and regulations governing purchases, including all selection laws, retainage and bonds, prevailing wages, and any other requirements appropriate.
10. The City of Lynnwood shall advertise the Roster annually on behalf of both parties, shall receive and review contractor applications, maintain the list of contractors, and make that list and the applications

available to the joining agency. The joining agency shall be independently responsible to determine that the selected contractors are responsible contractors according to the decision and opinion of the joining agency. The City of Lynnwood shall make an initial determination of responsibility, but this initial decision shall be for the convenience of the joining agency only and shall not constitute a decision of responsibility that the City of Lynnwood may be held liable for. It is instead the responsibility of the joining agency to determine responsibility in whatever manner that the joining agency feels is appropriate and consistent with applicable laws.

11. The City of Lynnwood and the joining agency shall each be independently responsible to conduct a quotation or bid process consistent with any ordinance, laws or requirements of their agency.
12. The City of Lynnwood and the joining agency shall each be independently responsible for issuing a contract and/or purchase order directly to the awarded contractor(s).
13. The City of Lynnwood does not accept responsibility or liability for the performance of any contractor used by the joining agency as a result of this Agreement.
14. Each agency shall be independently responsible for any payments directly to any contractor that is employed as a result of this Agreement.
15. The joining agency hereby agrees to indemnify and hold harmless the City of Lynnwood, its officers, employees and agents from any and all claims, actions, costs, damages and expenses of any nature arising out of or in conjunction with any act authorized by this agreement.

Shared Architects & Engineers Roster

16. The City of Lynnwood is the lead agency.
17. The joining agency shall express intent in using the Shared A&E Roster. Such intent does not impose a mandatory or continuous use of the Roster, but simply establishes the eligibility to use the Roster upon the convenience and interest of the joining agency. This interest may be expressed to Lynnwood at any time.
18. The joining agency may use the Shared Architects & Engineers Roster that has been established and maintained by the City of Lynnwood, to select Architectural and Engineering firms for interviews and contracts as allowed and in accordance by their local municipal code(s). The Shared Architects and Engineers Roster has been established for shared use by the City of Lynnwood and other public agencies.
19. The City of Lynnwood and the joining agency named herein shall each be independently responsible for their own and the firm's compliance with all additional or varying laws and regulations governing services, including all selection laws and any other requirements as appropriate.
20. The City of Lynnwood shall advertise the Roster annually on behalf of both parties, shall receive and review firm's applications, maintain the list of Architects and Engineers, and make that list, the applications, and the qualifications available to the joining agency. The joining agency shall be independently responsible to determine that the selected firms are responsible according to the decision and opinion of the joining agency. The City of Lynnwood shall make an initial determination of responsibility, but this initial decision shall be for the convenience of the joining agency only and shall not constitute a decision of responsibility that the City of Lynnwood may be held liable for. It is instead the responsibility of the joining agency to determine responsibility in whatever manner that the joining agency feels is appropriate and consistent with applicable laws.

21. The City of Lynnwood and the joining agency shall each be independently responsible to conduct a selection process consistent with any ordinance, laws or requirements of their agency.
22. The City of Lynnwood and the joining agency shall each be independently responsible for issuing a contract and/or purchase order directly to the awarded Architectural or Engineering firm.
23. The City of Lynnwood does not accept responsibility or liability for the performance of any Architect or Engineering firm used by the joining agency as a result of this Agreement.
24. Each agency shall be independently responsible for any payments directly to firm that is employed as a result of this Agreement.
25. The joining agency hereby agrees to indemnify and hold harmless the City of Lynnwood, its officers, employees and agents from any and all claims, actions, costs, damages and expenses of any nature arising out of or in conjunction with any act authorized by this agreement.

This Agreement shall remain in force until terminated upon written notice by either party.

6.20.010 Diking District No. 1.

Diking District No. 1 is declared to be duly organized.

The boundaries of said district are hereby established as follows:

Beginning at the intersection of the County Road, or present dike, with the E point of what is known as Pleasant Ridge, in Section 10, Township 33 N, R 3 E.W.M.; thence S to the North Fork of the Skagit River, thence NE along the river bank, to the intersection with Skagit River; thence NE, N and NW along the W bank of Skagit River to what is known as Wiles Slough in Section 13, Township 34 N, R 3 E.W.M.; thence SW along said slough to its intersection with the W line of the SE $\frac{1}{4}$ of Section 14, thence S to the center of Section 23, thence W and SW along the County Road to the W line of the SE $\frac{1}{4}$ of Section 21, thence S to the center of Section 28, thence W $\frac{1}{2}$ mile, thence S to the intersection of a dike on the N bank of what is commonly known as Wallace Slough, thence SW, along the outer line of said dike, to the dike dividing what has heretofore been known as dike districts Nos. 1 and 9, thence SE along the center of the last mentioned dike to the intersection with the N point of the aforesaid Pleasant Ridge in Section 32, Township 34 N, R 3 E.W.M., thence along the County Road in a SE direction to the place of beginning. (Res., 19)

6.20.020 Diking District No. 2.

Diking District No. 2 is declared to be duly organized.

The boundaries of said district are hereby established as follows:

Beginning at the intersection of the N and S centerline of Section 24, Township 33 N, R 3 E.W.M. with the N bank of Freshwater Slough, said point being about 1760 feet S of the center of said Section 24, thence NW along the N bank of Freshwater Slough, which is also the S line of Dike District No. 2, to a point opposite the slough known as the W Branch of Freshwater Slough near the S line of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$, said Section 24; thence W to the intersection of W Branch of Freshwater Slough and Freshwater Slough; thence S following the centerline of W Branch of Freshwater Slough, which is also the E line of Dike District No. 18, to Freshwater Slough about 700 feet S of the N line of Section 25, said Township and Range, thence NE

following up the centerline of Freshwater Slough to a point where Freshwater Slough comes from the E at a point about 400 feet East of the N and S centerline of said Section 24; thence N to S bank of Freshwater Slough; thence NW along bank of Slough to place of beginning.

(Res., 1935)

Said district being further described as:

Beginning at a point in the county road in front of D. E. Mages' building, which is situated on Lot 2 of Section 1, Township 33 N, R 3 E.W.M., thence running in a N direction along said county road and the W bank of the S Fork of the Skagit River to its junction with the N Fork of said River; thence down the left bank of the N Fork of Skagit River to its intersection with Dry Slough; thence down the E bank of Dry Slough to its intersection with Freshwater Slough; thence along the left bank of said Freshwater Slough to its junction with the S fork of the Skagit River; thence in a N direction along W bank of the S Fork of Skagit River to the place of beginning, containing about 2600 acres more or less. (Res., 1895; 4 CJ 217)

6.20.030 Diking District No. 3.

Diking District No. 3 is declared to be duly organized.

The boundaries of said District are hereby established as follows:

Commencing on the E bank of Skagit River at the foot of the hill, in Lot 8 of Section 19, Township 34, R 4 E.W.M. thence S along the bank of River to intersection with Fisher Slough, so known and called, in Section 30, Township 33 N, R 3 E.W.M. thence E along the N bank of said Fisher Slough to the foot of hill in Section 29, thence N along the foot of hill to the place of beginning. (Res., 1895; 4 CJ 254)

6.20.040 Diking District No. 4.

Diking District No. 4 is declared to be duly organized.

The boundaries of said district are hereby established as follows:

Commencing at a point where the N line of Section 28, Township 36 N, R 3 E.W.M. intersects the line of ordinary high-tide on the shore of Bellingham Bay; thence from said point extending E along the N line of said Section 28, and Section 27, to the W line of the right-of-way of the Great Northern Railway Company; thence in a SE direction along the W line of said right-of-way to a point where said right-of-way intersects the E line of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 27; thence S through the center of said Section 27 to the S line thereof; thence E to the NW corner of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 34; thence S through the center of the NE $\frac{1}{4}$ of Section 34 to the NW corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of said Section 34; thence E along the N line of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of said Section 34 to the E line thereof; thence S along the E line of said Section 34 to the SE corner thereof; thence W along the S line of said Section 34 to the center of that certain slough known as Edison Slough; thence following along the center of said Slough in a W direction to a point where said Slough intersects the W line of Section 33; thence N along said W line of Section 33 to a point where said Section line intersects the shoreline of Bellingham Bay; thence following said shoreline of said Bellingham Bay in a NE direction to the place of beginning, all of said description being in Township 36 N, R 3 E.W.M., Skagit County, Washington.

Said district being further described as:

Government Lots 1, 2, 3 and 10, of Section 32, Township 36 N, R 3 E.W.M.

Also that portion of Government Lot 2 of Section 33, Township 36 N, R 3 E.W.M. described as follows: Beginning at a point 82.5 feet N of the meander corner post in the right bank of the N Samish River where the Section line between Sections 32 and 33 crosses said N Samish River; thence N 265.32 feet; thence E 204.6 feet; thence S 161.04 feet; thence S 63° W 229.68 feet, more or less, to the point of beginning, EXCEPT road, ditch and dike rights-of-way.

6.20.050 Diking District No. 5.

Diking District No. 5 is declared to be duly organized.

The boundaries of said district are hereby established as follows:

Commencing at the NW corner of the NE ¼ of Section 1, Township 35 N, R 2 E.W.M.; thence due E along the line of present dyke to a point where said dike strikes the shore line on the N boundary of the Samish Peninsula, thence following the present dike up the right bank of Samish River to a point where said river intersects the County Road, said joint being about 20 rods N of the SE corner of Section 8, Township 35 N, R 3 E.W.M. thence S in said County Road to the SE corner NE ¼ of Section 17, thence due W to SW corner of SE ¼ of NE ¼ of Section 18, where it intersects the County Road thence S on County Road, to Joe Leary Slough, thence along the line of present dike to the mouth of said slough. Thence along the W shore line of Samish Peninsula, following present dike to place of beginning, containing 2,880 acres. (Res., 1895)

Said district being further described as follows:

A ditch the centerline of which begins at the S line of the N ½ of the N ½ of Section 7, Township 35 N, R 3 E.W.M. at a point where the fence between the lands in said subdivision of said Section owned and farmed by N. McCullough and Charles Matson is situated, which said fence is upon the line established and recognized for many years last past as the true line between the SW ¼ of the SE ¼ and the SE ¼ of the SW ¼ of said Section 6 and also as the line between the NW ¼ of the NE ¼ and the NE ¼ of the NW ¼ of Section 7 said Township and Range and extends N 2391 feet from said point along said line and fence to the center of a slough into which said ditch will empty.

Diking District No. 6 is declared to be duly organized.

The boundaries of said district are hereby established as follows:

Beginning at a point 516 feet E of the ¼ corner between Sections 25 and 26, Township 34 N, R 3 E.W.M. and following general direction of County Road to intersection with dike of Diking District No. 1.

6.20.070 Diking District No. 8.

Diking District No. 8 is declared to be duly organized.

The boundaries of said district are hereby established as follows:

Diking District No. 9 is declared to be duly organized.

The boundaries of said district are hereby established as follows:

Beginning at the N point of Pleasand Ridge in Section 32, Township 34 N, R 3 E.W.M. where the County Road crosses the Dike which divides, what has heretofore been known as Diking Districts Nos. 1 and 9, thence N along said dike to the S bank of Sullivans Slough thence W along the S bank of said Slough through Sections 29 and 30 to its intersection with the main channel of said Sullivans Slough, thence S along the E bank of Sullivans Slough through Sections 30 and 31 to a point where the present dike of said Diking District No. 9 bears away from the said slough towards the hill, thence along the outer line of the said dike in a S and SE direction through Section 31 of the aforesaid Township and Section 6 of Township 33 N, R 3 E.W.M. to the foot of the hill on or near the line between the SE ¼ and NE ¼ of said Section 6, thence in a NE direction along the foot of the hill or ridge to the place of beginning. 6.20.090 Diking District No. 12.

Diking District No. 12 is declared to be duly organized.

The boundaries of said district are hereby established as follows:

Beginning at a point on the N (right) bank of the Skagit River where said river bank is intersected by the W line of Lot 3, Section 4, Township 34 N, R 4 E.W.M., said point lying in the present boundary line of Diking District No. 12, as established by the Board of Commissioners of Skagit County and as the same is recorded in Volume 4, at page 267, Records of Commissioners Proceedings, Skagit County, Washington; thence N along the W line of the said Lot 3 to the old Puget Sound and Baker River Railroad right-of-way; thence NE along said right-of-way to the S line of the NW ¼ of the SE ¼ of Section 33, Township 35 N, R 4 E.W.M.; thence E along said S line to the bank of the Skagit River; thence N along the river bank to the E line of the said NW ¼ of the SE ¼; thence N to the S line of the E. F. Lafayette County Road No. 102; thence NE along the S line of said road to a point which is 100 feet SE of the centerline of the Great Northern Railway line, Rockport-Anacortes Branch, formerly known as the Seattle and Northern Railway; thence NE parallel to the said railway and county road, and 100 feet from the centerline of the railway to E line of Section 27, said Township and range; thence N to the NE corner of the SE ¼ of the said Section 27; thence W to the NW corner of the NW ¼ of Section 27; thence S to the N line of the S ½ of the SW ¼ of the NW ¼ of Section 27; thence W to the NW corner of the S ½ of the SE ¼ of the NE ¼ of Section 28, said Township and Range; thence S to the N line of the S ½ of the SW ¼ of the SE ¼ of said Section 28; thence W to the N-S centerline of said Section 28; thence S to the S ¼ corner of said section; being a point on the previously established boundary line of the said Diking District; thence W along said boundary to the NW corner of the NE ¼ of the NE ¼ of Section 32, Township 35 N, R 4 E.W.M.; thence continuing W along the N line of Section 32, and Section 31, to the N ¼ corner of the said Section 31, being a point in the previously established boundary line of the said district; thence following said previously established boundary line, S to the S ¼ corner of the said Section 31; thence E to the SW corner of the SE ¼ of the SE ¼ of Section 32, said Township and Range; thence N to the N line of Section 32; thence E along the N line of Section 32 and Section 33 to an intersection with the W bank of Gage's Slough; thence E along the N and W bank of the said slough to a point on the S right-of-way line of the Great Northern Railway right-of-way line of the Great Northern Railway

River Dam in Section 31, Township 37 N, Range 9 E.W.M. (June 12, 1962)

Beginning at the NE corner of Section 22, Township 33 N, R 3 E.W.M., going S 0° 23 minutes E for 979.4', thence N 88° 44 minutes W for 1708.8' to the true point of beginning, thence S 73° 6 minutes W for 98.0', thence N 62° 35 minutes W a distance of 185', thence S 42° 54 minutes W for a distance of 245'; thence S 57° 22 minutes W for 211', thence S 36° 50 minutes for a distance of 145', thence S 2° 55 minutes W for a distance of 125', thence S 18° 24 minutes E for a distance 352', thence S 0° 51 minutes E for a distance of 191', thence S 13° 24 minutes W for a distance of 264', thence S 70° 9 minutes W for a distance of 133'; thence S 36° 24 minutes W for a distance of 367'; thence S 28° 10 minutes W for a distance of 121'; thence S 9° 2 minutes W for a distance of 183', thence S 6° 43 minutes E for a distance of 84', thence S 59° 0' for a distance of 233', thence S 41° 17 minutes W for a distance of 190', to an intersection with centerline of the dike right-of-way along the SW side of this property. Right-of-way to extend 30' on either side of the above described premises, 60' in width, containing 5.75 acres. And:

Diking District No. 15 is declared to be duly organized.

The boundaries of said district are hereby established as follows:

Beginning at the center of Brown's Slough to the N line of Section 16, Township 33 N, R 3 E.W.M.; thence S following the centerline of Brown's Slough to the intersection with the centerline of Hall's Slough in the NE ¼ of the SE ¼ of said Section 16; thence following the centerline of Hall's Slough in a S and W direction to the S line of said Section 16; thence W to its SW corner; thence continuing W to the W line of Lot 4, Section 17; thence N to a point 60 rods N of the NW corner of said Lot 4; thence NW to a point 80 rods E of the center of Section 17; thence W to a point 100' W of the center of Section 17; thence N 80 rods; thence W to the SW corner of the NE ¼ of the NW ¼ of Section 17; thence N to the N fork of the Skagit River; thence E and N along the N fork of the Skagit River to its intersection with Brown's Slough in Section 10; thence S along the centerline of Brown's Slough to the place of beginning; all of the said above described lands being in Township 33 N, R 3 E.W.M., Skagit County, Washington. Diking District No. 17 is declared to be duly organized.

The boundaries of said district are hereby established as follows:

Beginning at the NW corner of the NE ¼ of Section 17, in Township 34 N, R 4 E.W.M.; thence W to the W line of the right-of-way of the Seattle and Montana Railway Company; thence N along the W line of said right-of-way to the Skagit River; thence down the Skagit River following the bank of the said river at low water line around what is known as "the bend" of the river to the point where the section line between Sections 18 and 19 in said Township and Range intersects with the said bank of the said river; thence E along said section line to the SW corner of said Section 17; thence NE in a straight line to the SE corner of the NE ¼ of said Section 17; thence NW in a straight line to the point of beginning.

6.20.130 Diking District No. 18.

Diking District No. 18 is declared to be duly organized.

The boundaries of said district are hereby established as follows:
