Pre-Registration: Call the Victim Panel Voicemail at **(425) 388-7269**. You may also register, in person, beginning at 8:30 AM for Saturday classes, or at 6:00 PM for Tuesday classes.

Payment: **\$50 FEE Payable with Cash**, Cashier's Check or Money Order **ONLY**.

Additional Payments: If you do NOT call to reschedule your appointment one hour PRIOR to your scheduled panel, you will be charged an additional **\$10.00 fee**. This fee will be imposed each time you are scheduled and do not attend. No admittance without payment.

Time/Rules: Doors are opened and registration begins at **6:00 PM on Tuesdays and 8:30 AM on Saturdays**. Doors are closed at 6:30 PM on Tuesdays and 9:00 AM on Saturdays. No one will be admitted after the doors are closed. The Victim Panel lasts approximately 90 minutes. If it is suspected that you are under the influence of alcohol or any other drug, or have an odor of alcohol or marijuana, you will not be allowed to attend. No guests under the age of 12 are permitted.

Registration: Pre-Register by calling the Victim Panel Voicemail at **425-388-7269** or you may also register at the door 30 minutes prior to a scheduled Victim Panel.

Payment: **\$50 FEE Payable with Cash**, Cashier's Check or Money Order ONLY.

Additional Payments: If you do NOT reschedule your appointment one hour PRIOR to your scheduled panel, you will be charged an additional **\$10.00 fee**. This fee will be imposed **each time** you are scheduled and do not attend. No one is admitted without proper payment.

Time: Doors are open and registration begins at **6:00 PM on Tuesdays and 8:30 AM on Saturdays**. Doors are closed at 6:30 PM on Tuesdays and 9:00 AM on Saturdays. Victim Panels last approximately two hours.

Guests: Friends, relatives, and driver's education students are welcome, but they may not sit with attendees. No fee is charged for guests or driver's education students.

Behavior: If it is **SUSPECTED** that you are under the influence of alcohol or any other drug, or have an odor of alcohol or marijuana, you will not be allowed to attend and your court will be notified. Please do not consume alcohol or use any other drug 24 hours prior to attending. If you are disruptive or disrespectful to the speakers, staff, or other attendees, you will be asked to leave and your court will be notified.

Credit: You will receive proof of attendance at the end of the panel as long as you: attend the complete presentation, pay your required fee, follow the rules listed above, and fill out all paperwork as requested.
