**INVITATION FOR BIDS**

**SUBMITTAL OF SEALED BIDS:**

Sealed bid proposals (“Bids”) will be received by the Public Works Deputy Director, or the Public Works Deputy Director’s representative, at Lynnwood City Hall, 19100 44<sup>th</sup> Avenue W., Lynnwood, Snohomish County, Washington, 98036, until 2:00 p.m., May 12, 2016 for the following project (“Project”):

**Bike2Health Project**

Capitalized terms not defined in this Invitation for Bids shall have the meanings set forth in the Project Manual of which this Invitation for Bids is a part.

**BID OPENING:**

At the time and date above stated, the Bids will be publicly opened and read aloud (“Bid Opening”). Bids are to be submitted only on the bid proposal forms provided with the Project Manual. All Bids must be accompanied by a bid bond, cashier’s check, certified check, or postal money order in an amount not less than five percent (5%) of the total amount of the Bid. Bids received after the time fixed for the Bid Opening will not be considered.

**DESCRIPTION OF WORK:**

The Work to be performed shall include channelization of roadway and bike lanes for:

- 212<sup>th</sup> Street SW from SR 99 to 63<sup>rd</sup> Avenue W
- 200<sup>th</sup> Street SW from 68<sup>th</sup> Avenue W to SR 99 and 52<sup>nd</sup> Avenue W to 48<sup>th</sup> Avenue W
- 52<sup>nd</sup> Avenue W from 212<sup>th</sup> Street SW to 208<sup>th</sup> Street SW
- 48<sup>th</sup> Avenue W from 200<sup>th</sup> Street SW to 188<sup>th</sup> Place SW

Modification of existing flashing beacon system, 100LF of new cement concrete curb, gutter and sidewalk on 48<sup>th</sup> Avenue W, replacement of existing catch basin frame and grate, new permanent signage, and new route and way finding signage throughout the City at key locations.

All Bids shall be based upon compliance with the Project Manual (including, without limitation, the Contract Plans and Specifications). The estimated cost range for this project is \$ 600,000 to \$725,000. The project shall be Physically Completed within 30 working days of the Notice to Proceed.

No Bidder may withdraw its Bid within sixty (60) days after the actual date of the Bid Opening.
