RESIDENTS 61+ OR DISABLED UTILITY REBATE

Step 1- New or Renewal? Check One

New Application (Apply 7/1- 8/31Only) Renewal (Accepted 6/1- 8/31Only)

WHO 61+ or disabled residential property occupant who lived at & paid rent/mortgage for property within the City of Lynnwood corporate limits for at least 6 months before the date of application, whose income for the *entire household* (anyone over 18) was less than \$51,851.10 (Adjusted Gross) in the most recent tax year (2019). Must not be receiving any other discount or rebate from the city.

WHAT/ WHEN A yearly rebate based on utility charges. Date of payment and amount paid will depend upon number of applicants. *Applicants must reapply each year.* Renewal forms are not automatically mailed.

WHY In June of 2007, the City Council adopted ordinances providing for utility rate discounts and rebates for residents inside the City of Lynnwood who meet specific criteria. LMC Ordinance No. 3345

HOW Complete all steps below and submit application with required documents.

Step 1- Complete A OR B-

A. My City of Lynnwood utility account, which is in my name, # is _____.

B. I do not have a City of Lynnwood utility account in my name. I am proving my address by attaching **PROOF OF SERVICE** from the PUD for at least 6 months of service at this address before the date of this application. **DO NOT ATTACH COPIES OF PUD BILLS.** Ask PUD to provide **YOU** (only) with proof of service and then you can give a copy to us. Step 2 - Attach to your application:

Copy of picture ID (Example-Driver's License) for applicant (Blacken out confidential info such as SS#, Driver's License #.)

Proof of income for ALL household members over 18. Examples-Most recent tax return, Social Security or Disability Award Letter or any other proof of income. (Do not send originals.)

Step 3 - Submit completed application with required documents- (Pick One)

Online- Download and Save this application. (Down arrow, top right). Email completed form with required documents attached to: ubdiscounts@lynnwoodwa.gov
