



# FREE OR REDUCED SCHOOL LUNCH CITY OF LYNNWOOD UTILITY REBATE-

LYNNWOOD MUNICIPAL CODE 13.20.080

**WHO?** Families living in and paying rent or mortgage for property within the corporate limits of the City of Lynnwood, whose children have been approved for the current school year for Free/Reduced Lunch through the Edmonds School District and have lived at this address for at least 6 months before application. Applicant may not be receiving any other utility rebate or utility discount from the city. Go to “Do I Live In Lynnwood Map” at [www.lynnwoodwa.gov](http://www.lynnwoodwa.gov) if you are unsure if you live in Lynnwood city limits.

**WHAT?** A rebate to you based on water/sewer charges paid to City of Lynnwood and the number of applicants for a rebate. If approved, a check will be mailed to the person shown on the ESD Free/Reduced Lunch approval form.

**WHEN?** Applications accepted **September 1<sup>st</sup> – October 31<sup>st</sup> ONLY**. Date of rebate will depend on number of applicants.

**WHERE? / HOW?** Complete all steps below and return your application, with all documentation attached.

**STEP 1**-Prove your City of Lynnwood residency by completing A **OR** B, below:

**A** I have a City of Lynnwood utility account *in my name*. The account # is \_\_\_\_\_. If you are a renter, we can bill you with property owner or manager permission. Have them contact us if you would like billing in your name.

**B** I do not have a City of Lynnwood utility account. I am proving my address by attaching **PROOF OF SERVICE** from the PUD for at least 6 months before the date of applying for this rebate. Do Not attach copies of your PUD bills or ask PUD to email or mail proof to us. Make a copy of the proof they give you. Attach the copy to this application. Must be in your name.

**STEP 2**- Attach a copy of your Free/Reduced Lunch approval letter from Edmonds School District for the current school year.
