**MULTI & MOBILE UNIT UTILITY REBATE APPLICATION**

Applications accepted 10/1 to 11/1 ONLY

**WHO**-Lynnwood property owners who are Snohomish County Property Tax Exempt and occupy a multiple or mobile unit within the city corporate limits\*, where the City of Lynnwood provides utility service but does not bill the owner directly. (See our website for “Do I live in Lynnwood Map” if you are unsure if you are within the city limits.)

**WHAT/WHEN**- Rebate based on utility charges and Snohomish County Property Tax Exemption level. Rebate application will not be automatically mailed to you. Must reapply each year, 10/1 to 11/1 ONLY. LMC Ordinance No. 3345.

**You will need to return your completed application with both items below:**

1-Copy of Property Tax Exemption approval letter from Snohomish County or a printout from Snohomish County. Snohomish County Phone #:425-388-3540.

Print Proof of Exemption: <https://snohomishcountywa.gov/5167/Assessor>. Enter your address in “Property Summary Search” and print section that identifies you and the level of your exemption.

2-*Proof of Service* from the PUD for at least 1 year of service before the date you submit your application. Ask PUD for this proof and then **you** can give a copy to us. **Please do not attach copies of PUD bills or ask PUD to mail or email proof to city.** PUD Phone #: 425-783-1000

Once you have completed your application, submit it *with required documents*- (Pick One)

Deposit- Drive-up drop box in the City Hall parking lot, across from the main.
