Good evening Mayor, council, and people of Lynnwood. I appreciate the opportunity to advocate for the recently proposed paid DEI position. The time for change is now. People are tired of waiting. Look around you: People of color feel unsafe, forgotten, and unheard. The social and political climates of our nation speak to the need for a permanent, paid position within the executive office that is dedicated to ensuring social justice becomes a key part of city practice. We are making strides in this work with employee groups and volunteer commissions, but we must do more. I understand that funds are tight now due to the ongoing pandemic, but this crisis has underscored the intersectionality between race, health, and economic outcomes, and people of color are suffering most of all. Civil unrest in response to the treatment of black people by law enforcement highlights the need for further community engagement and a change in how we approach public safety. Our people need us and this expenditure would allow us to finally put our money where our mouth is. The fact of the matter is that a budget line item comes with expectations and a level of accountability that we simply can't demand from our volunteers. This issue is important enough to warrant a dedicated staff member whose job it would be to ensure we make good on our duty to treat all of you with the respect and dignity you deserve and to let you who may still be on the fence, know that the proposed position request was not predicated on fear-mongering or alarmism but rather on history and feedback from our community listening sessions. Remember that in 2018, just outside the city limits, eight white supremacists beat and
Laptife an esvolution or ecating administration of kaypfe as

racially abused two people of color at a local bar. Just a few months ago, one of our own officers was racially harassed on the job. In July of this year, community members of color expressed feelings of insecurity when doing business in our city or when dealing with police. These issues are not just on TV, and they are not happening somewhere else. These problems are endemic to every corner of this country, including Lynnwood, and it is our duty to respond. Lastly, know that the proposed position would not be a new one, but rather an existing position redefined for the current needs of the city. Until we commit to funding a paid position dedicated to social justice and to upholding our promise of being an inclusive city where all are truly welcome, we are just going through the motions. Lynnwood deserves more. Thank you.

I am here as a resident of City of Lynnwood and as the Chair of Diversity, Equity and Inclusion to advocate for the proposed paid DEI position. Referring to Lynnwood Municipal Code Ch 2.58 which describes the duties of the DEI Commission as an advisory whose duties shall be to monitor demographic trends in our city and to identify and recommend to the mayor and city council ways to encourage mutual understanding among our citizens about the increasing demographic diversity of our city." We are here from the DEI Commission to do exactly that which is to advise the mayor and city council to move forward with the DEI position. On July 23, 2018 the DEIC requested and proposed action plans to create a Diversity, Equity and Inclusion office for the City of Lynnwood to address Racial and Social Justice issues. Due to budget and administrative constraints our proposal was not taken into consideration, and were advised to put in our proposal for the next budgetary cycle of the 2021-2022 Budget. On July 15, 2020 after hearing from the community and listening to issues concerning our residents we have arrived again at the point that it is necessary for our City to have a Diversity, Equity and Inclusion office with emphasis on Racial and Social Justice issues, and we are acting on that need by respectfully requesting a budget for the DEI position. Residents of Lynnwood have spoken loud and clear to the leadership of our City, and have requested a bold action from our leaders to address Racial and Social justice issues, as well as Equity and Inclusion concerns. A paid position

at the DEI office should be funded to focus on inequities in our community. I understand the budgetary limitations and financial constrains of the City during this time of COVID 19 pandemic, but the time is now for creating a Diversity, Equity and Inclusion office with a paid position within the executive office to implement Social and Racial Equity. City of Lynnwood should join in the regional efforts to achieve equity and justice for all, and recognize the necessity of having a DEI office to dismantle and remove structural barriers that have prevented people of our marginalized communities to have economic, social and racial equities. This office will design relevant solutions and services to the marginalized communities and work in integration of equity practices throughout the City to continue to be a safe, Welcoming and livable city. Dear Mayor and City Council,

As our city grows, we need to sustain certain levels of law and order with more police patrols and more public safety, not less. When light rail opens in Lynnwood in 2024, we cannot allow our city to lose control over the crime and the homeless population expanding from Everett and downtown Seattle. Defunding the police or a reduction in the police budget are not the same thing, however they can have the same unintended and devastating consequences to our community. The city's department heads including our police department have been asked to reduce their budgets and to consider eliminating non-essential programs. Volunteer programs like VIPS and Citizens Patrol are considered non-essential and therefore face possible funding elimination because of the proposed \$3.7 million dollar police budget cut. Each year the Citizens Patrol and VIPS volunteers put in over 11,000 volunteer hours which is equivalent to 5.4 full time employees. The city receives virtually free labor from these types of volunteer programs so I would encourage the city to continue maintaining these volunteer programs and provide them with adequate funding to help serve and improve our community.

Furthermore, by substantially decreasing the police budget by \$3.7 million dollars, I hope this will not deprive our police officers of critical de-escalation training necessary to assist individuals with special needs and mental health issues. Social workers are a major part in the fight against homelessness so I am hoping that the city finds a new social worker to replace the only one that we had. This is a critical public safety program that I feel the city should continue to expand on and not restrict funding or personnel from.

I am pleased that the city is making efforts to cut spending across the board and I understand the need for cost reductions. As a business owner myself, I agree that it is financially responsible to minimize costs and reduce spending during these hard times. This is how my business survived and weathered the storm during the last major recession. Reducing costs is a smart thing to do during difficult times and I am looking forward to seeing how the city plans to reduce the budget in the coming weeks.

In summary, I am reminding you that we are a growing city and we need to maintain adequate levels of funding to help tackle the crime and homelessness crisis that we face now and into the near future. Vote to support our first responders who keep our community members and businesses safe. I would also like to urge the council to invest more in innovation and technology. As our city grows, ensure that our IT department and DBS have adequate resources not just for growth, but to have a competitive advantage over our neighboring cities.

Please keep all these considerations in mind when you go to vote on our final budget in November. I look forward to seeing the detailed budget reports in the coming weeks.

Thank you for your written comments; I will ensure this email (and your previous email) is forwarded to the Mayor and City Council.

Please know that the City of Lynnwood does not set rates for solid waste or natural gas. These rates are set by the Washington Utilities and Transportation Commission (WUTC). Home energy audits are also not provided by the City, but instead by SnoPUD and/or Puget Sound Energy.

The City of Lynnwood *does* set the rates for utilities owned and operated by the City: water, sanitary sewer, and stormwater. Also, the City collects a 6% tax on most utilities.

I will forward your suggestion for photo enforcement on Olympic View Drive to our traffic engineer.

A few years ago, the City carefully investigated your complaints regarding trees on neighboring properties. I don't have any new information regarding that matter.

Please know that I welcome your input and feedback, and my comments here are not intended to be contrary or to dissuade you. Thank you for your ongoing interest in community matters. Corbitt

As a twenty year resident of the city, it is important that I get to remain in my home. I'm physically disabled and my rambler allows that, as long as utility rates can be discounted, including property taxes, garbage, water/sewer, gas and electric. There are no discounts for garbage or for gas. As a one person household, who's somewhat of a minimalist, the rates can be very difficult. Most times I only need to put my mini can out once a month, if that. Yet there's no incentive to reduce ones waste, which is appalling. Gas is also not discounted. Why not? Putting my heat on 65° when home during the day is the best I can do. Yet my bill can be upwards of \$100/month. One is not allowed to receive a house energy check-up if they've had one, which I have, but it was over nineteen years ago. That needs to change. I could more easily afford my utility bills if I didn't have to constantly pay to have my roof and gutters cleared of my neighbors 25+ over 110' tall Fir trees that are overgrown for the area and neglected. They cost me a ton of money, including having to get their roots cut out of my sewerline and holes in my roof and ceiling patched. There's a City Ordinance that protects one from nuisance hazardous trees, but the City of Lynnwood will not enforce it, wrongfully claiming it's a civil matter. It's reasonable to expect that one's neighbors should not be allowed to neglect hazardous trees, that cause extreme costs and stress to a neighbor, due to their size and location.

So bottom line, discount all the utilities and enforce current ordinances. Neither of those things

would cost the city much. Install ticket cameras on OVD near my home and the revenue will pour in.
