**SUBMITTAL OF SEALED BIDS:**

Sealed Bid Proposals (“Bids”) will be received by the Public Works Deputy Director, or the Public Works Deputy Director’s representative, at Lynnwood City Hall, 19100 44<sup>th</sup> Avenue W., Lynnwood, Snohomish County, Washington, 98036, until 10:30 am, March 8, 2018, for the following project (“Project”):

**2018 Chip Seal Program**

Capitalized terms not defined in this Invitation for Bids shall have the meanings set forth in the Project Manual of which this Invitation for Bids is a part.

**BID OPENING:**

At the time and date above stated, the Bids will be publicly opened and read aloud (“Bid Opening”) at Lynnwood City Hall, 19100 44<sup>th</sup> Avenue W., Lynnwood, Snohomish County, Washington, 98036, in City Hall Council Chambers. Bids are to be submitted only on the Bid Proposal forms provided with the Project Manual. All Bids must be accompanied by a Bid bond, cashier’s check, certified check, or postal money order in an amount not less than five percent (5%) of the total amount of the Bid. Bids received after the time fixed for the Bid Opening will not be considered.

**DESCRIPTION OF WORK:**

This Contract provides for the improvement of various City of Lynnwood roadways by street sweeping, asphalt for fog seal, bituminous surface treatment, HMA for pavement repair, crack sealing, raised pavement markers, paint line, plastic pavement markings and other work, all in accordance with the attached Contract Plans, these Contract Provisions, and the Standard Specifications.

All Bids shall be based upon compliance with the Project Manual (including, without limitation, the Contract Plans and Specifications). The estimated cost range for this Project is \$950,000 (Base Bid) to \$2,500,000 (All alternatives). The Project shall be Physically Completed within 80 working days of the Notice to Proceed.

**OBTAINING BID DOCUMENTS:**

The Project Manual for this Project (including the Contract Plans, Specifications and all other Contract Documents) may be examined at the Lynnwood City Hall.
