FIRST AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN PUBLIC UTILITY DISTRICT NO. 1 OF SNOHOMISH COUNTY AND CITY OF LYNNWOOD FOR THE 196TH ST SW IMPROVEMENT PROJECT

This FIRST AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN PUBLIC UTILITY DISTRICT NO. 1 OF SNOHOMISH COUNTY AND CITY OF LYNNWOOD FOR THE 196TH ST SW IMPROVEMENT PROJECT ("First Amendment") is made by and between Public Utility District No. 1 of Snohomish County, a Washington municipal corporation ("District") and the City of Lynnwood, a Washington municipal corporation ("City") on the ____ day of February, 2021. The City and the Developer are collectively referred to as the "Parties" or individually as a "Party."

RECITALS

- A. The Parties entered into the Interlocal Agreement between Public Utility District No. 1 of Snohomish County and the City of Lynnwood for the 196th St. SW Improvement Project, dated October 8, 2020 (the "Agreement"). The Agreement's purpose is to facilitate the construction and coordination of the replacement of the District's overhead utility system with an underground utility system within the area of, and as part of, the City's 196th Street SW Improvement Project (the "Project").
- **B.** Exhibit B to the Agreement lists the District facility "Betterments" that the City will construct and install as part of the Project, at the District's cost. After the Parties entered into the Agreement, the City awarded the contract for the Project. An addendum issued during the bidding process changed bid item numbers for the Betterments and added one Betterment item.
- C. Therefore, the Parties desire to amend Exhibit B to the Agreement to reflect the Bid Item Numbers included in the contract documents for the Project, and to include the Betterment item added during the bidding and contract award process, in accordance with Section 15.2 of the Agreement.
- **NOW, THEREFORE**, in consideration of the mutual covenants contained herein, the Parties agree to amend the Agreement as described below.
- 1. <u>Amendment to Exhibit B</u>. Exhibit "B" to the Agreement is amended to read as Exhibit "B," attached hereto and incorporated herein by this reference.
- **2.** Effect of this Amendment. Unless expressly revised by this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect and unchanged.
