

Project Manager	Qualifications of Project Manager provide <u>up</u> to three (3) previous projects for the proposed Project Manager that demonstrates his/her experience with one or more roles/responsibilities on similar projects, and/or elements of such projects, specifically detention center & public safety facilities experience. Include client's name, project's completion date and roles/responsibilities for each project. <i>Note: this information may be used for reference check.</i>	30
Project Team	Qualifications of Project Team List key personnel for the project team and their role/responsibility on the project. Provide the related qualifications and experience of key personnel and provide up to three (3) examples of prior experience on similar projects within the last 3 years, specifically detention center & public safety facilities experience. Include the name of the project(s), owner(s), dates of the project(s), and roles/responsibilities of key personnel on those project(s). Note: this information may be used for reference check.	30
