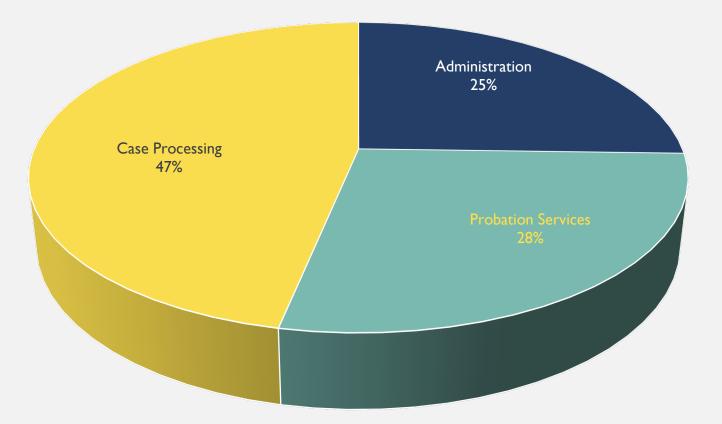








## Municipal Court Budget by Program



Total Proposed 2021-2022 Municipal Court Budget: \$2,853,573

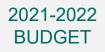
