# Status of the 2020 Financial "Gap" in the General Fund – Sonja Springer, Finance Director (3:20 p.m.)

- Finance Director Springer discussed the status of the 2020 Financial "Gap" in the General Fund and steps the City has taken to offset the \$9.4 million revenue shortage in 2020. She also discussed six options to consider for filling the remaining gap of approximately \$2.2 million. The Administration's recommendation is Option 1 to allow the City to temporarily use a portion of the General Fund unassigned fund balance of Revenue Stabilization Fund Balance.
- Strategic Planner Corbitt Loch reviewed proposed amendments to Financial Policies which would be incorporated in option 1.
  - Council comments and questions followed.
  - There was discussion about using the possibility of using the Revenue Stabilization Fund due to the emergency nature of the situation in combination with one or more other options.

### April 2020 Monthly Financial Report – Sonja Springer, Finance Director (4:20 p.m.)

• Finance Director Springer discussed the April 2020 monthly financial report showing operating expenditures and revenues for the General Fund. She emphasized that the sales tax revenue was

better than expected. It is expected that it will be worse in the months to come. Compared to the same period is 2019, revenues are 15.09% below expectations, but this has been mitigated by significant reductions in expenditures. She also reviewed the Economic Development Infrastructure Fund (EDIF) Summary, the Real Estate Excise Tax (REET) fund, Utilities Fund, and the City's Total Cash and Investment Balances and 2020 Investment Interest Earnings. Council comments and questions followed.
