**AN ORDINANCE OF THE CITY OF LYNNWOOD, WASHINGTON,
TRANSPORTATION BENEFIT DISTRICT AMENDING THE 2016
BUDGET FOR THE CITY OF LYNNWOOD, WASHINGTON,
TRANSPORTATION BENEFIT DISTRICT; AND PROVIDING FOR AN
EFFECTIVE DATE, SEVERABILITY, AND SUMMARY PUBLICATION.**

WHEREAS, on May 24, 2010 the Lynnwood City Council did establish the
Lynnwood Transportation Benefit District; and,

WHEREAS, on November 18, 2015 the Transportation Benefit District Board
adopted a budget for fiscal year 2016; and,

WHEREAS, due to various reasons, the Transportation Benefit District Board
desires to amend the 2016 budget; NOW, THEREFORE,

THE BOARD OF THE CITY OF LYNNWOOD, WASHINGTON, TRANSPORTATION
BENEFIT DISTRICT, DO ORDAIN AS FOLLOWS:

Section 1. The 2016 Budget for the Lynnwood Transportation Benefit District for the year
ending December 31, 2016 is hereby amended.
