

Lynnwood Mobile Food Vendor Code Update (File No. CAM-26-0001)

Date of this Notice: March 19, 2026

Notice: The Lynnwood Planning Commission and City Council will conduct individual public hearings on the above referenced code amendment. Interested community members are invited to attend these public hearings and to provide comments, either orally or in writing.

Project Description: The City of Lynnwood is proposing changes to Title 8, Unified Development Code regarding Mobile Food Vendors to improve code clarity, provide updated processes, and update general food vendor regulations. Changes to Title 8 include updating the 8.35 Use Tables to permit food vendors, adding code from LMC 5.18 Mobile Food Vendors to the Food and Beverage limitations sections to create a mobile food vendor permit, repealing LMC 5.18, and updating 8.99.0250 Definitions to include updated mobile food vendor definitions.
