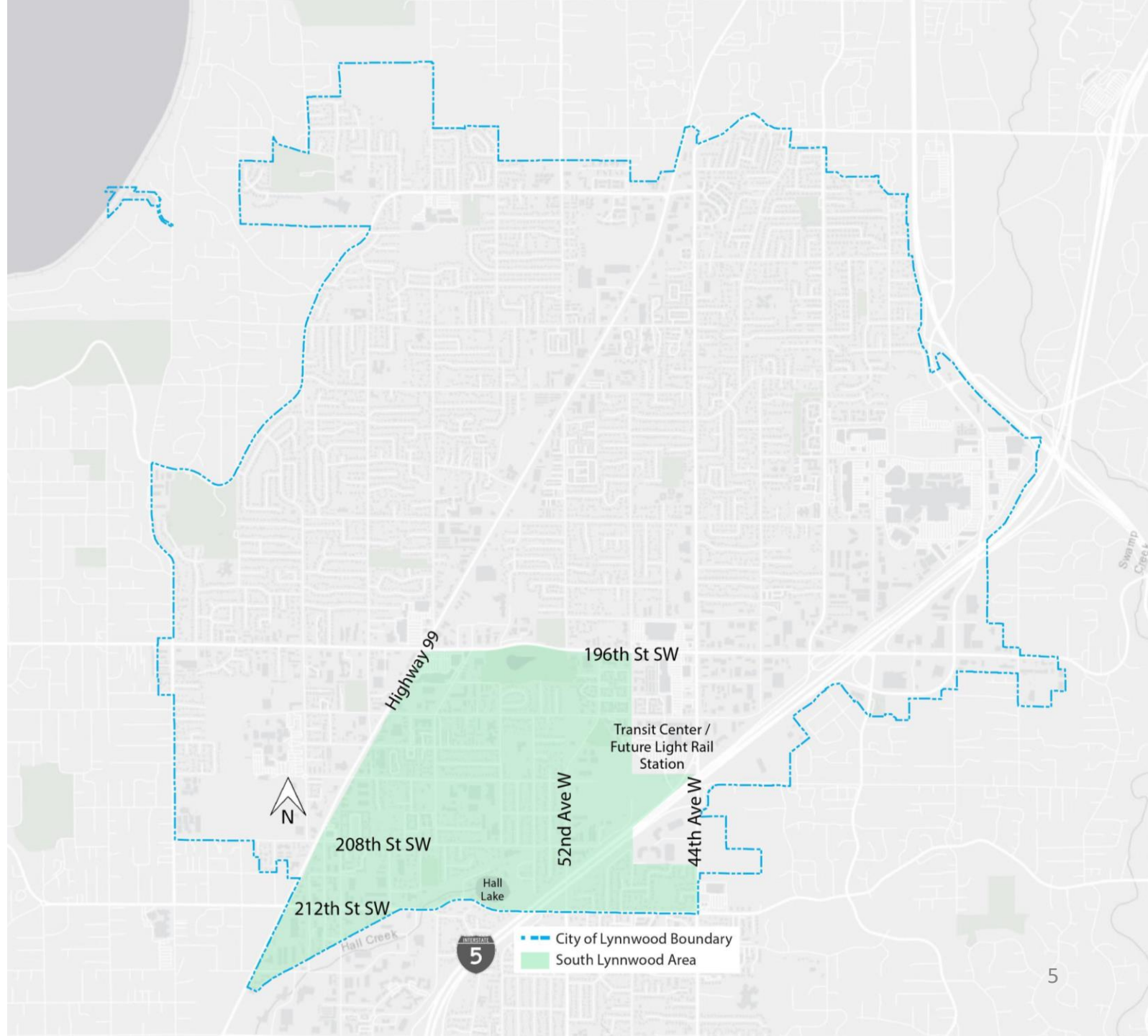

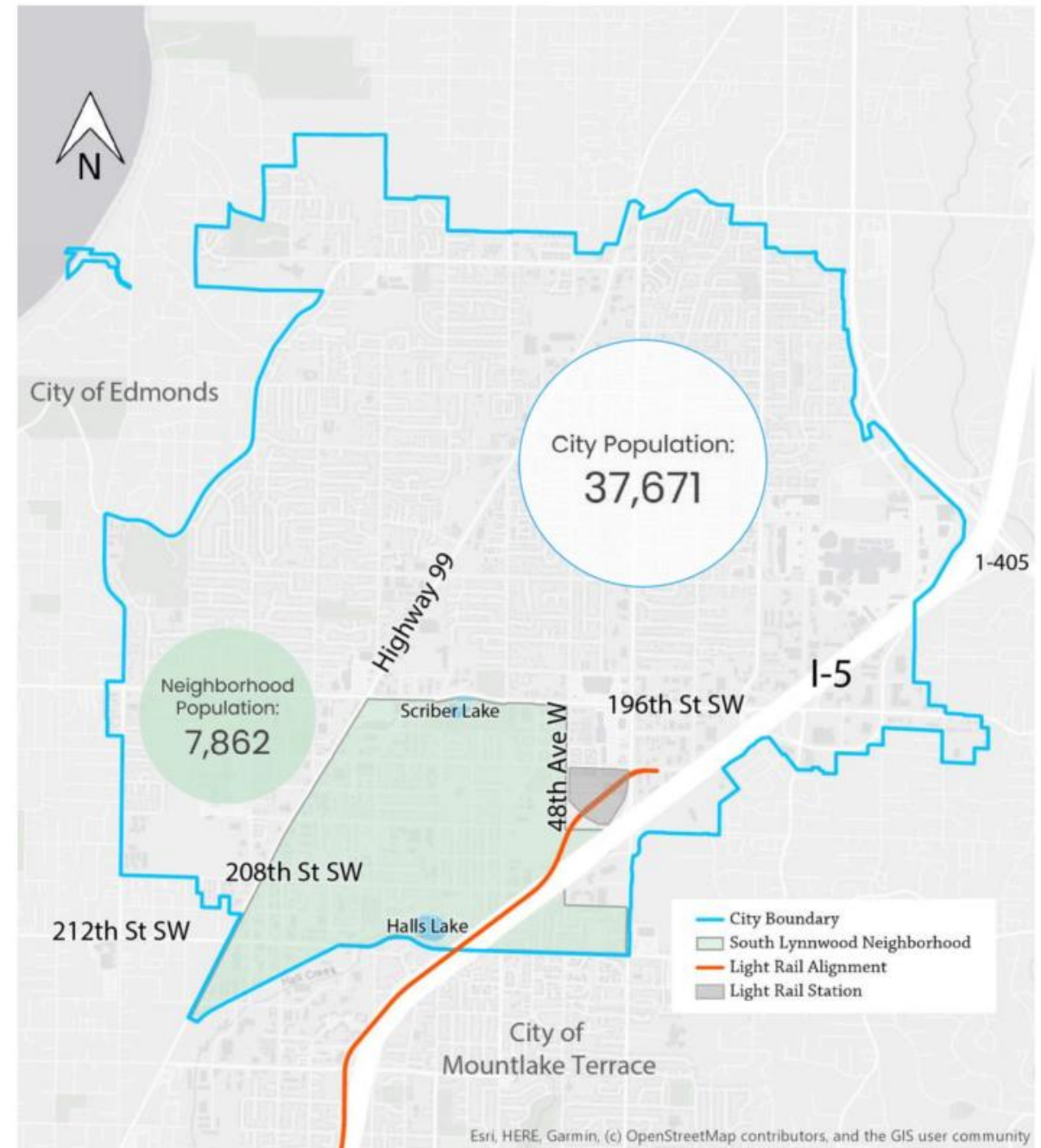

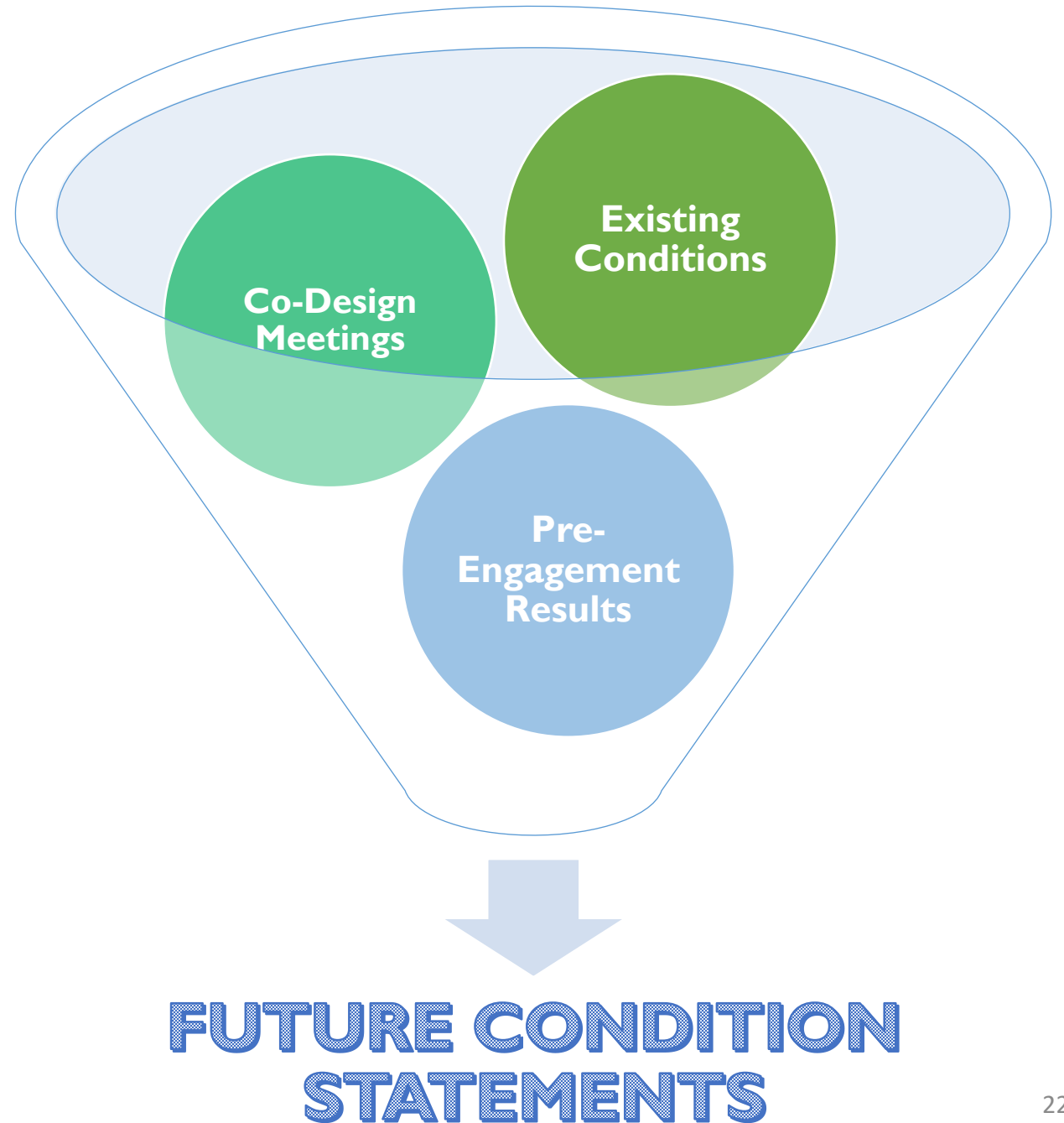

FUTURE CONDITION STATEMENTS

Summary of Existing Conditions Findings

- The neighborhood is racially and ethnically diverse – more than it was in year 2000
- The community is concerned about the rising costs of housing and displacement
- There are approximately 350 businesses in South Lynnwood
- Most land in the City zoned for industrial uses
- Parks are valued by the community
- Neighborhood sees opportunity with incoming light rail

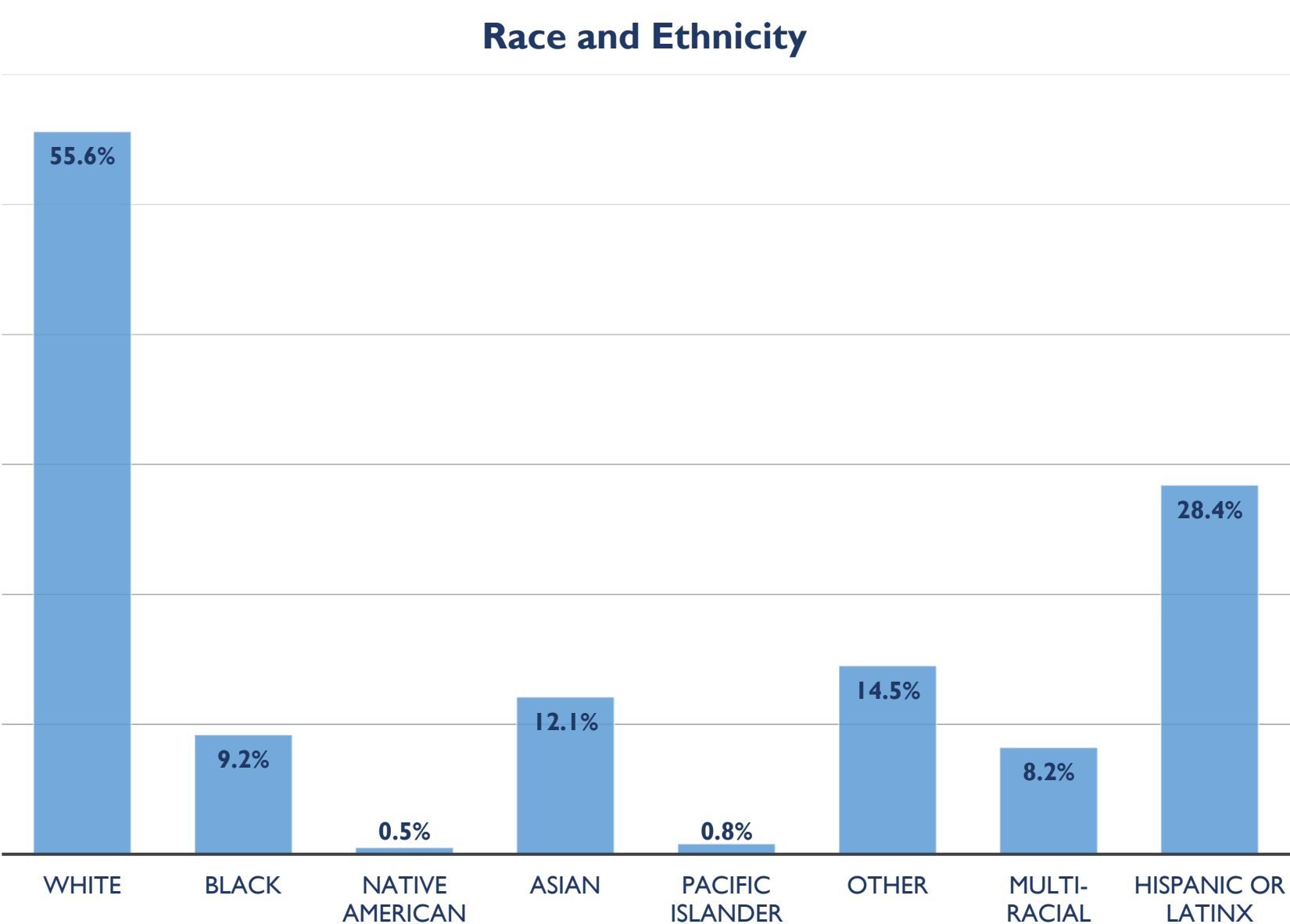

28% of the neighborhood identifies as Hispanic/Latinx compared to **13%** of Lynnwood as a whole.

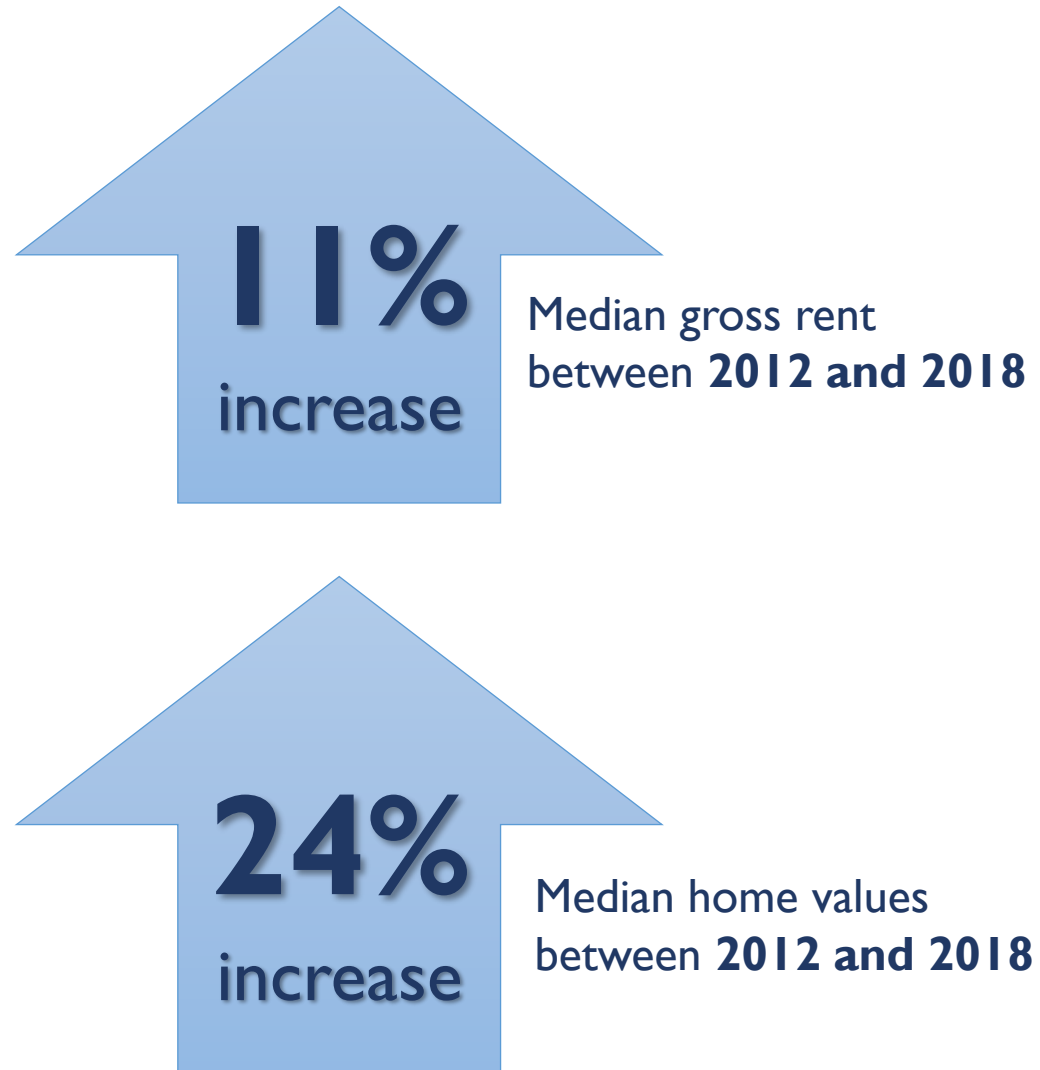

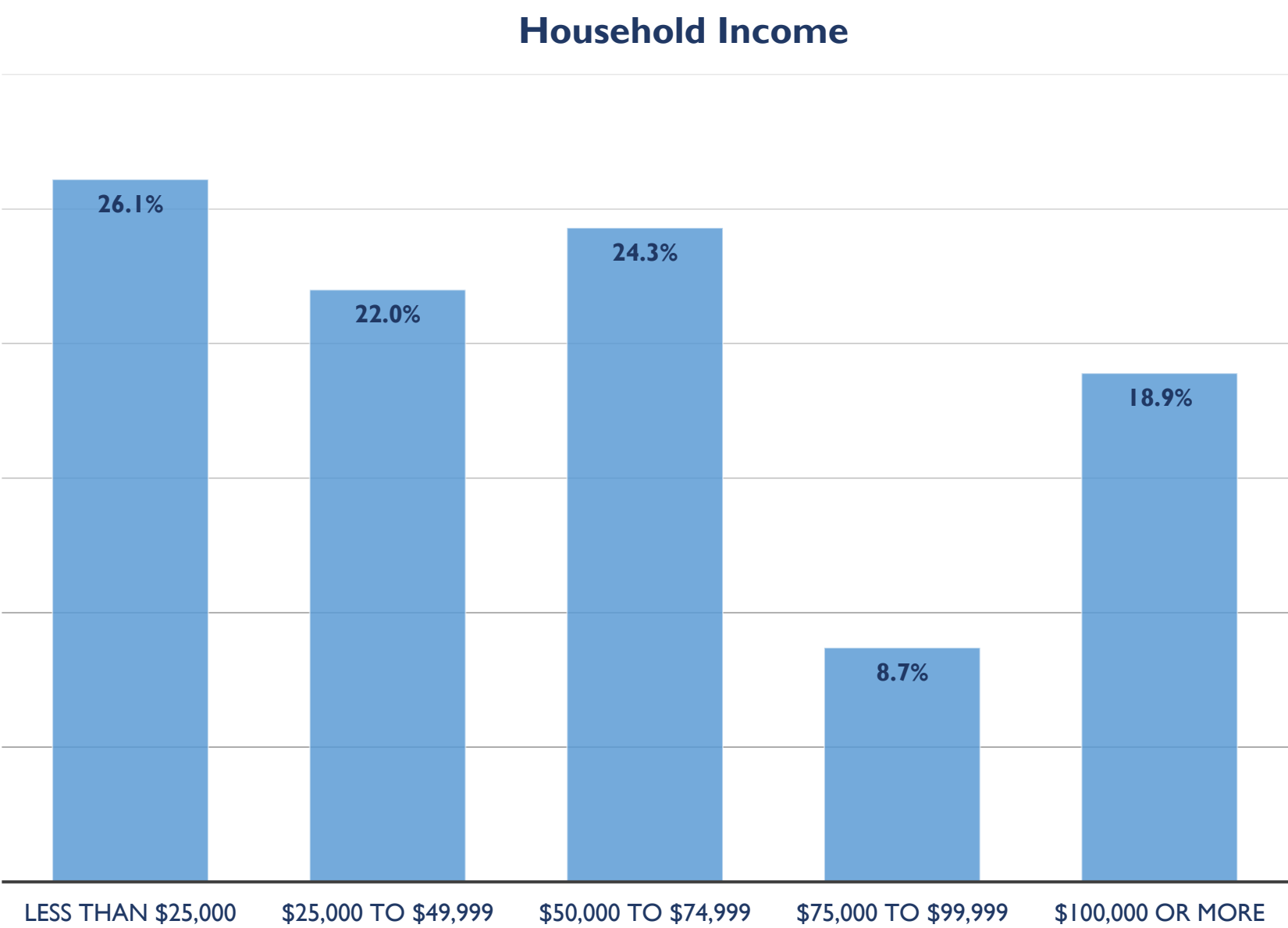

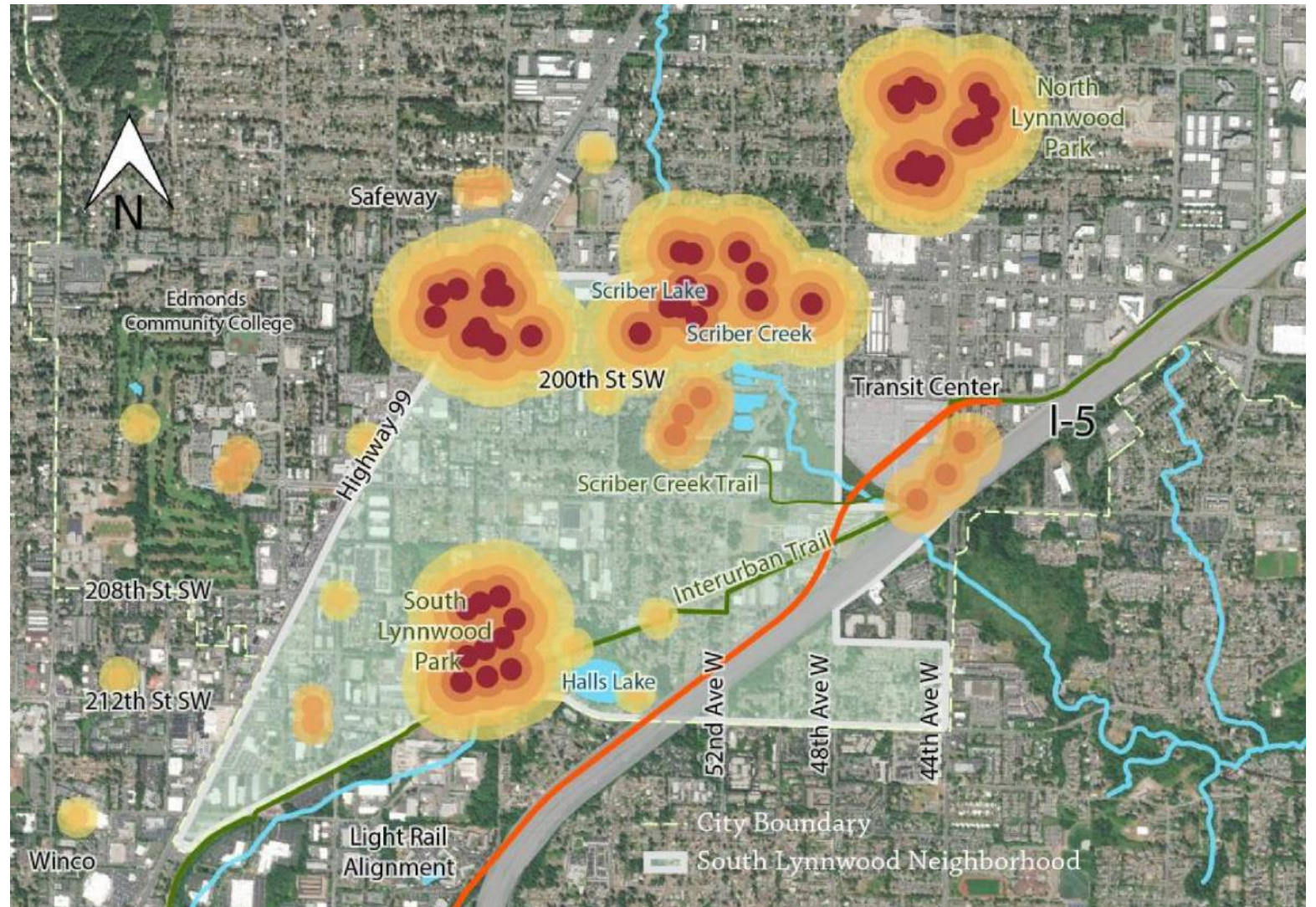

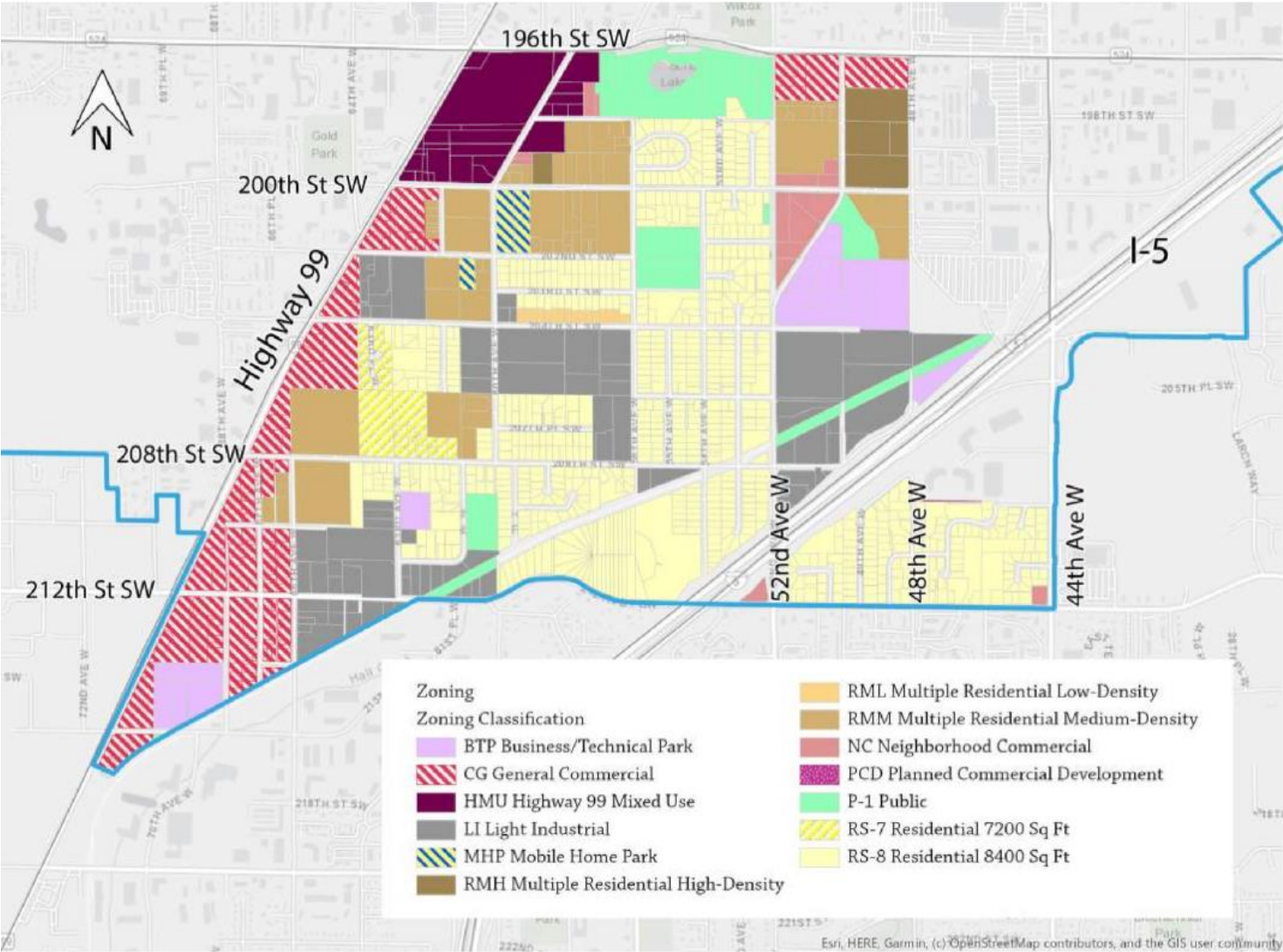

There is a **greater portion of land zoned for industrial uses** in the Neighborhood than the City as a whole.



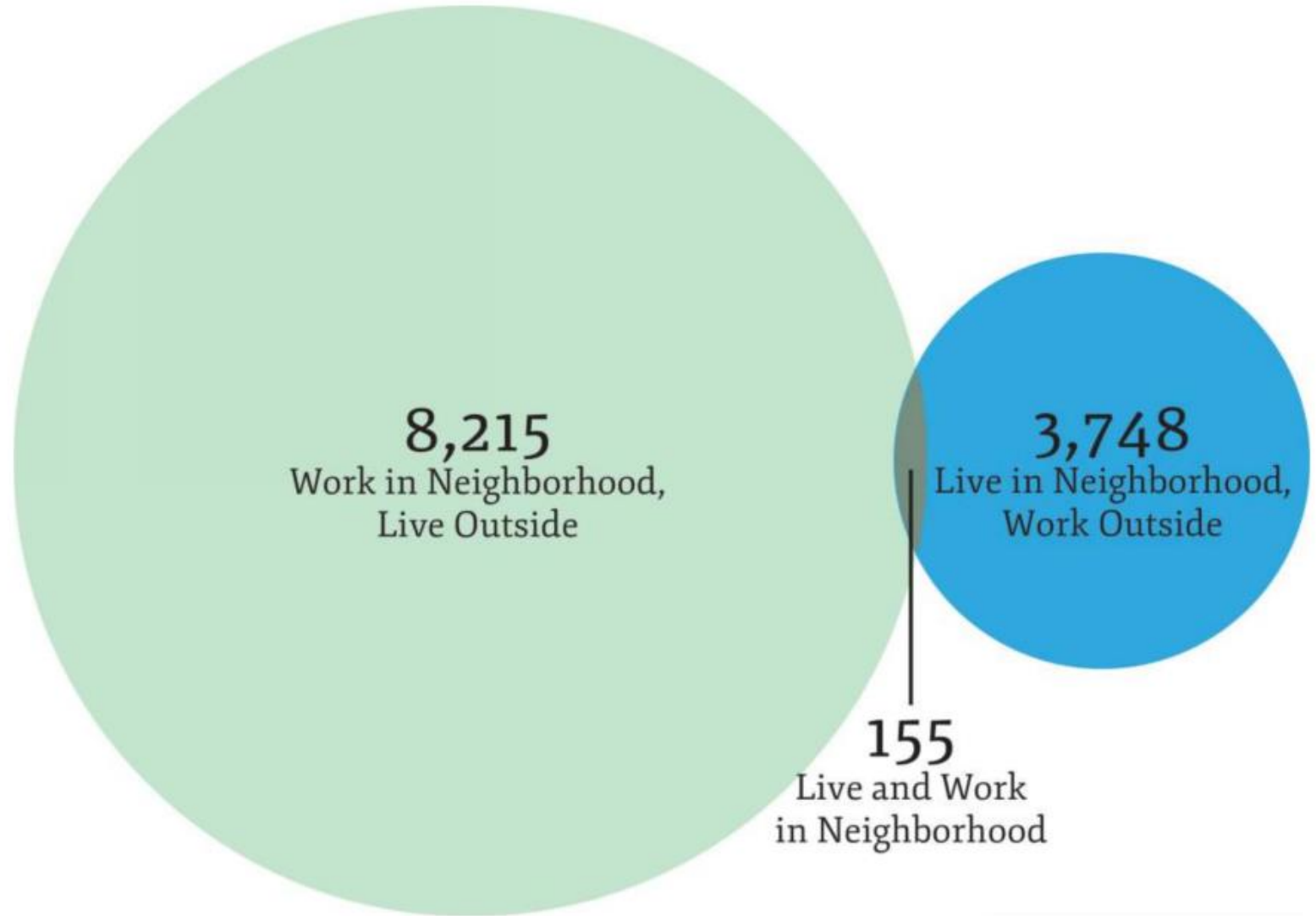

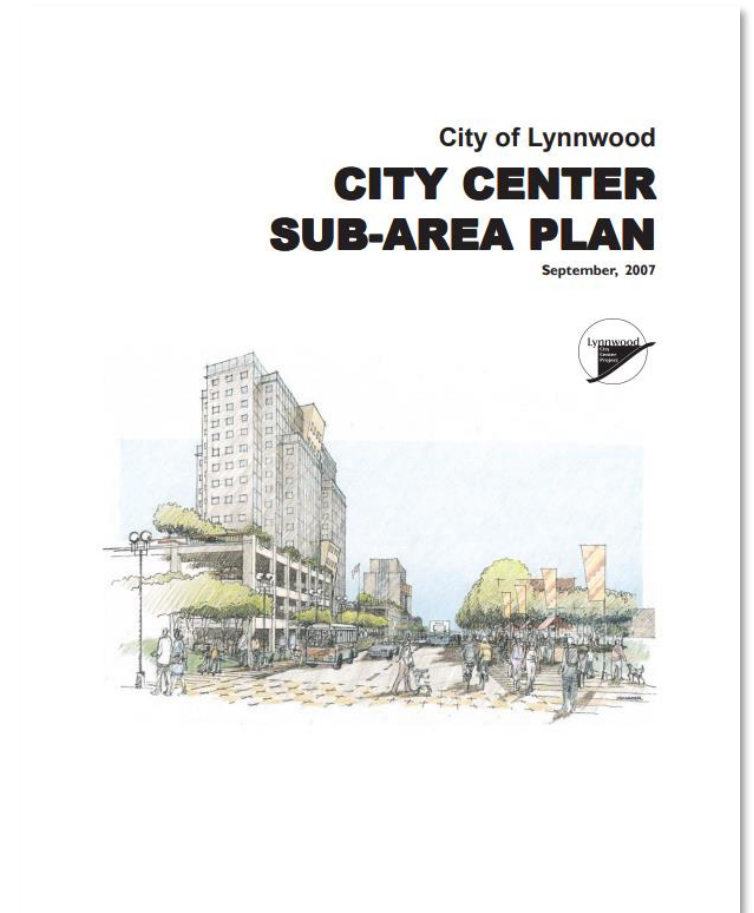

 - Envisions transformation from auto-oriented commercial strip to multi-modal, multi-use corridor

 - Envisions a compact, intense and lively city center with opportunity for culture, commerce, and habitation.



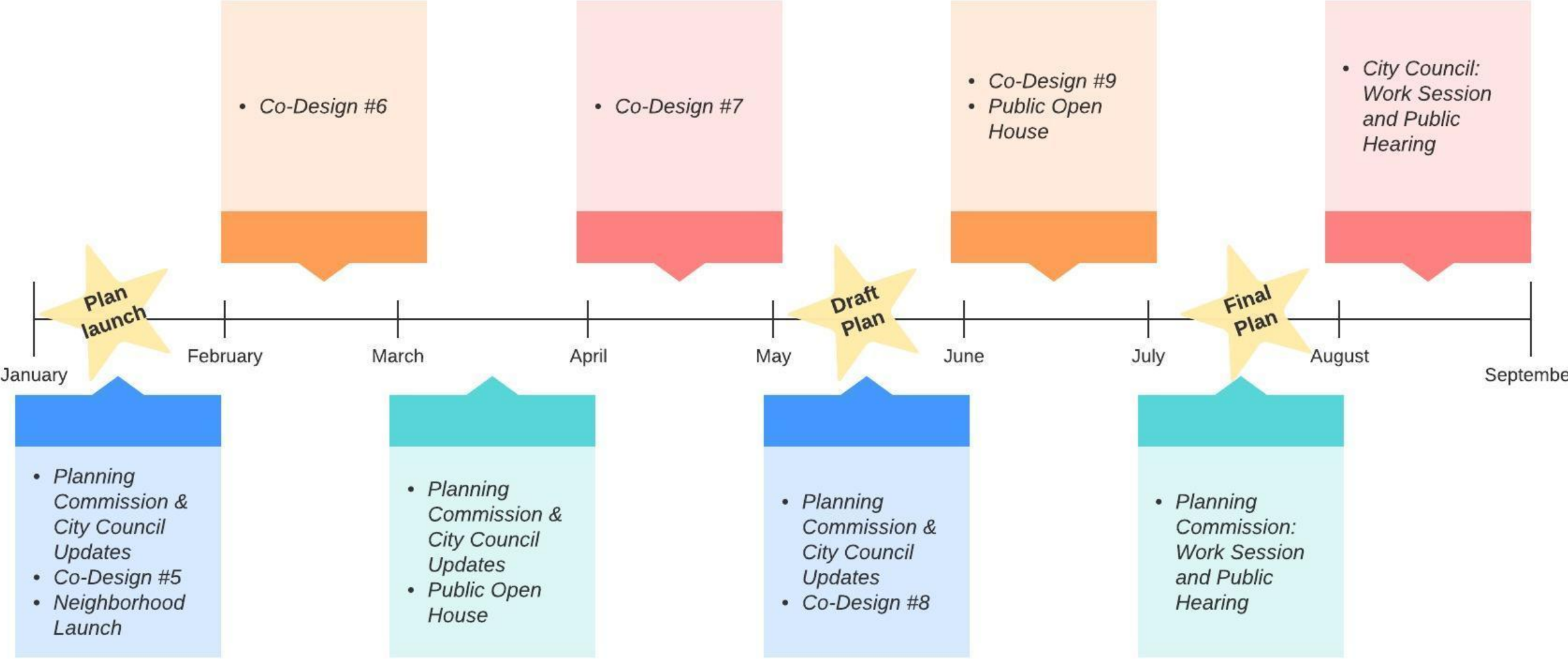
