

## South Lynnwood Park Renovation and Revitalization Project

On May 10th, we officially kicked off construction of the South Lynnwood Park Renovation & Revitalization project with a groundbreaking ceremony. We were joined by several dignitaries and project leads to celebrate the start of construction. Over the next several months, the park will be closed for renovation which includes replacing and expanding the playground, the addition of a picnic shelter and park seating, resurfacing the tennis/pickleball courts, creating a new basketball court, adding a turf soccer field, improving drainage of the grass lawn area, and addressing all ADA barriers on site. Last fall, the restroom building ADA upgrades were completed along with a colorful new mural titled *Grateful Steward* by artist Gabrielle Abbott. Construction is anticipated to be completed this October. This project has funding support from The Trust for

## **Lynnwood Utility Billing**

During the COVID-19 pandemic, some utility customers have understandably had trouble keeping up with payments for water, sewer, and stormwater. It is important that customers continue to pay what they can so account balances do not become overwhelming. As an example, customers should pay the most recent charges, plus 10% or more of older, unpaid charges.

The ongoing installation of "smart" water meters throughout the City delayed some billings and caused confusion regarding due dates for payments. New statements have corrected due dates. We apologize for the confusion.

## Reduce Rates & Rebates

For qualifying low-income households, the City offers a variety of reduced utility rates and rebates. To see if your household qualifies, visit our City's website or call our Utility Billing team. 


## **Water Quality Report**



## Community Justice Center

This project will rebuild and re-imagine our Community Justice Center. We are excited to be designing and building a purpose-built police department, a re-imagined misdemeanor jail, and a remodeled court, which will allow us the necessary space and function to bring the best justice services to our community. Project design is completed and we are currently out to bid for a contractor. A groundbreaking will be scheduled for late this summer. ## Lynnwood Link Extension

The project to extend light rail service from Northgate (opening 2021) to Lynnwood (opening 2024) is well underway. Sound Transit has begun construction of the Lynnwood City Center Station Parking Garage which will contain over 1,600 parking stalls in a five-story structure built to LEED silver standards. # 196th Street SW Improvements

Construction continues of this project which will widen 196th St SW (SR524) between 48th Ave W and 36th Ave W. Nighttime work on water main and drainage systems installations and fire hydrant work is ongoing. Planned improvements are designed to reduce traffic congestion, better accommodate bus and transit travel, increase business access, and promote walkability and safety.

## Everett Link Extension—ST3

The Everett Link Extension Project is just getting started. Sound Transit is drafting plans to conduct equitable community engagement through environmental review and development of station and track alignment alternatives. As a part of the ST3 project, Lynnwood's second light rail station will be constructed in proximity to Alderwood mall. Sound Transit and the City are working with the City of Everett, Snohomish County, and other transportation agencies to plan station locations and the guideway route.

# Regional Growth Center Subarea Plan

Lynnwood has begun working on a Regional Growth Center (RGC) Subarea Plan. The RGC was previously approved by City Council and includes the City Center and the Alderwood mall areas. This plan will address new development, transportation and transit facilities, recreation and infrastructure improvements. # South Lynnwood Neighborhood Plan

The South Lynnwood Neighborhood is a mix of residential, commercial, and industrial land uses conveniently located to transit, transportation, and the Interurban Trail. The plan will establish a community vision; identify infrastructure needs; identify projects and policies to stabilize housing for all families; preserve and improve parks and open space; provide opportunities for various land uses; create opportunities for businesses to grow; and improve access to transit.

Kinect @ Lynnwood is currently under construction and will provide 239 new housing units. The site is directly east of Sound Transit's Lynnwood City Center Station and is adjacent to the Interurban Trail.



Avalon Alderwood, located at the former Sears site, is under construction. The project includes ground floor retail and 328 new housing units. With this development, Alderwood mall will soon have mixed-use development with residences, retail, restaurants, and entertainment all in one location.



Lynnwood Place Phase 2 is under construction directly north of Alderwood mall, next to Costco. This project is a mixed-use development with 500 new housing units and ground floor retail and restaurants. Directly west of the mixed-use project is a new Home Depot. Both Avalon Alderwood and Lynnwood Place have great access to the Interurban Trail and Community Transit Bus Rapid Transit.
