

## A Message from the Chief

We are proud to present to our community the Lynnwood Police Department 2018 Annual Report.

2018 continued to provide challenges and opportunities for our community and our Department. We continue to work closely with Mayor Smith, City Council, and other City departments to deliver quality City services to our residents and visitors.

To be most effective, our Department continues to focus on a deliberative improvement process and to consciously align our decision making with that focus. This process ensures we continue building trusting relationships between the

Department and the diverse communities that we serve.

The professional and talented staff of the Lynnwood Police Department continue to provide proactive, competent, and effective public safety services to all persons, with the highest regard for human dignity. While doing so, we continue to commit to our three core Values of *Professionalism*, *Vigilance*, and *Community*.

As you read through this report, note the multifaceted and complex responsibilities of the various divisions and units within your Lynnwood Police Department. Our Department staff handle a tremendous volume of work in our effort to keep our community safe. While doing so, we pride ourselves in carrying out our work with a customer service mindset. We will continue to proactively work to make our Lynnwood community an enjoyable place to live, work and visit.

In 2018, we held our second annual Police Camp for area youth – and we continue to watch this program grow in both size and impact. The *Police Chief's Community Advisory Committee* is also in its second year. I am impressed that these committee members chose to spend this past year immersing themselves in learning and understanding our profession – to include touring the State Criminal Justice Training facility, attending police officer graduations, speaking with officers at roll calls, and evaluating and even training on our less lethal platforms as part of our ongoing focus on deescalation training and policy development. In just its third-year, our *Cops & Clergy* program has grown to over 50 faith -based organizations! These programs allow us to partner with our community in multiple ways which enhance and leverage our effectiveness in our great community.

Our Lynwood community continues to face many challenges. For the third year in a row, I must mention the opioid epidemic and its impact on individuals and communities. Opioid drug addiction, coupled with a resurgence in methamphetamine drug use, exacerbates our already fragmented mental health system and the many challenges surrounding homelessness. Drug addiction, mental illness, and homelessness do not exist in isolation from one another. They are often co-occurring, creating complex challenges which require complex solutions. As I have stated previously, these challenges and their solutions are not the police department's alone. Elected officials and policy makers, other City departments, non-profit organizations, business owners, and community members all share in this responsibility.



# **Patrol**

The Patrol Division is the largest and most visible division in the Lynnwood Police Department. Patrol is committed to serving our community through the prevention of crime and apprehension of violators and criminals. We strive to deliver a wide range of professional services to our diverse community; anytime, anywhere.

Currently, the Patrol Division has authorized staffing for one commander, five sergeants, twenty-four uniformed officers, one canine sergeant, three canine officers, one traffic sergeant, five traffic officers and two reserve patrol officers.



Officers and sergeants are deployed 24/7 on a variety of twelve-hour shifts. Throughout the year, we remain committed to pursue training opportunities, special projects, and directed enforcement activities within scheduled patrol shifts.

#### **Our Values in Action**

The primary goal of the Patrol Division is to provide enhanced service to the Lynnwood community. Our efforts are driven by our agency's core values of Professionalism, Vigilance, and Community.

#### **PROFESSIONALISM**

Officers assisted the Mountlake Terrace Police Department by stopping an occupied stolen vehicle. Lynnwood officers recognized one of the occupants as the suspect in an armed robbery that occurred in Lynnwood. Officers then obtained a written confession from the suspect, ensuring that he would be held accountable in court for his criminal misdeeds.

Officers responded to a suicidal man outside of a local hotel who threatened to shoot himself with a handgun. After hours of negotiation, it was apparent the man was not going to surrender. Officers used less lethal foam baton impact rounds to disrupt the man's efforts, which allowed them to take him into custody and bring him to the hospital for mental health treatment.

#### **VIGILANCE**

After an arson occurred outside of the city, an LPD officer spotted a suspect matching the description. Upon contact, the suspect smelled of gasoline and

was detained until a witness arrived and confirmed he was the arson suspect. After his arrest it was determined that this suspect had earlier smashed the windows of numerous cars at a car lot in Lynnwood. He was held accountable for his crime spree that night.

Officers responded to an impound yard on a report of a burglary and assault in progress. Three males were arrested after they drove into the secure impound lot, removed a backpack from a vehicle, and then rammed the gate to escape. A gun was later located inside the backpack. Suspects were booked on numerous charges.

#### COMMUNITY

A patrol officer responded to an unresponsive male believed to be overdosing on opioids. The officer administered two doses of Narcan to the subject, which revived him and saved his life.

An officer resourcefully located and climbed a ladder onto the second-story balcony of an apartment to rescue a five-year old autistic boy who had locked himself inside his apartment by himself.

Patrol officers and supervisors attended the annual Cops-N-Kids event at Alderwood Mall and interacted with hundreds of community members in a positive environment.

# Crime Scene Tech C.S.T.

Presently four crime scene technician officers are attached to patrol squads; staffing each of the squads with a specially trained officer and providing round-the-clock field coverage. Officers of the Crime Scene Technician unit respond to both routine and major incidents to assist other officers with evidence identification and collection.

At major crime scenes, additional CST officers may respond to assist with the collection of evidence and other scene processing duties. CST officers coordinate their duties and collection of forensic evidence with detectives from the Criminal Investigation Division.

The Crime Scene Technician Unit is currently supervised by a sergeant in the Criminal Investigation's Division.


At this time our department has two qualified ABIS (Automated Biometric Identification System) technicians who use a specialized computer network connected to both regional and national databases of known subjects to match latent prints recovered at crime scenes. Two additional department members are undergoing training to include ABIS technician as a collateral assignment.

# Traffic

The Lynnwood Police Department Traffic Section promotes and provides a safe transportation environment to motorists, pedal cyclists, and pedestrians through education, engineering, and enforcement to improve the quality of life of Lynnwood residents and visitors.

Functions of the Traffic Section include collision prevention and investigation, impaired driver enforcement, traffic control at civic functions, escorts and processions, assistance with high priority patrol calls when needed, community traffic complaint investigations, child safety restraint training, photo enforcement review, and other traffic-related training.

The Traffic Section demonstrates great community support by assisting in traffic calming, local public motorcycle safety demonstrations, and traffic safety talks to local civic groups.


We believe comprehensive customer service is a top priority that supports our agency's core values of *Professionalism, Vigilance, and Community.* The Traffic Section sought to respond to every community member who filed a traffic complaint. Each of the complainants received a phone call, letter, email, or personal visit from a traffic officer or the section supervisor. Officers implemented a response strategy specifically tailored to address the identified problem.

#### **NOTEWORTHY ACHIEVEMENTS**

Throughout 2018 members of the Traffic Section served as trainers in the areas of defensive tactics, drug and alcohol-impaired driving, collision investigation, field training of new patrol officers, and advanced motorcycle operations. Sergeant

Harris served as the Director of the National Association of Field Training Officers. He is a well respected and accomplished instructor, teaching a number of regional and national level advanced law enforcement classes. This leadership and collaborative effort is essential for unit success and is consistent with the overall agency vision.

Throughout the year, officers conducted a number of traffic details and emphasis patrols. These include focused enforcement operations for DUI, Distracted Driving, Seatbelt Enforcement, Motorcycle Safety, Pedestrian Safety, and Speed Enforcement. The Traffic Section also relies upon partnerships with our regional/state partners, in conjunction with the Washington State Traffic Safety Commission, to accomplish our unit mission.



# K-9 Unit



The Canine Unit supports the Patrol Division through the application of police service dogs trained in tracking, apprehension and narcotics detection in order to enhance officer safety, the capture of suspects and assist in evidence collection.

All three canine teams maintained a regimented training schedule in 2018 to ensure compliance with departmental policy and state accreditation standards. All three officers and their K-9 partners are accredited to the Master Handler standard.

All three Lynnwood canines are certified as dualpurpose teams capable of both human tracking and narcotic detection. In late 2018, the unit selected Officer Zacharia to begin K9 training in 2019.

The unit as a whole recovered over 20 pounds of illegal narcotics and assisted in the recovery of seven firearms.

\*A Canine contact is defined as any gripping of a person's body or clothing by the dog's mouth, irrespective of injury or damage. Additionally, any injury or damage to a person's body or clothing caused by contact with the dog's teeth, i.e., rakes, abrasions or tearing of clothing, will be reported.



#### CREECH AND EARL


Officer Creech and K9 Earl were deployed 124 times total leading to 40 arrests. 53 of those deployments were to "sniff" for narcotics. In one case, K9 Earl located over 15 pounds of illegal narcotics.



#### **DICKINSON AND ZANDO**

In 2018, Sergeant Dickinson and K9 Zando were deployed 50 times. These deployments led to the arrest of 24 individuals.

In May of 2018, Sergeant Dickinson and Zando arrested a bank robbery suspect who fled into a residential area.



#### **SHORTHILL AND ELI**

In 2018, Officer Shorthill and K-9 Eli were deployed 85 times. Their deployments resulted in the arrest of 51 criminal suspects.

In October of 2018, K9 Eli located two suspects who fled from a stolen vehicle and hid several blocks apart from each other.

# **SWAT**

North Sound Metro Special Weapons and Tactics (SWAT) Team responds to high-risk incidents that require specialized training and equipment and attempts to resolve potentially dangerous situations without injury or loss of life to officers, suspects, or uninvolved citizens.

#### **NORTH SOUND METRO SWAT**

The North Sound Metro SWAT Team is a multijurisdictional unit composed of two distinct elements; the SWAT (tactical) team, and the Hostage Negotiation Team (HNT). The team is comprised of officers from the following municipal jurisdictions: Bothell, Edmonds, Kirkland, Lake Forest Park, Lynnwood, Mill Creek, Monroe, Mountlake Terrace, Mukilteo, and Redmond. The team services a population base of well over 350,000 citizens. Current approved staffing for tactical operators is 36, plus 4 team commanders. HNT is allotted 13 officers. Command of the team is rotated between the participating agencies. From 2012 - 2017 the team Commander was from Lynnwood PD. In 2017 Kirkland PD took over Command duties for the team.

# ACTIVITY AND ACCOMPLISHMENTS

Over the past year, North Sound Metro SWAT conducted 14 operations, all of which had successful conclusions; no injury to victims, officers, or suspects.



#### **NOTEWORTHY EVENT**

North Sound Metro SWAT was requested by Lynnwood PD to serve a search warrant at a residence for a Violation of the Uniform Controlled Substances Act with Intent to deliver. The suspect was believed to be dealing both methamphetamine and heroin. The residence was believed to be occupied by 5 people and there were reportedly assault rifles and handguns within the residence. The suspect was taken into custody without incident.



#### **TRAINING**

Training was conducted monthly with an emphasis on building one tactically sound cohesive team comprised of officers from the ten cities. Additionally, the tactical team participated in a weeklong training cycle at Shaw Shooting, located in Idaho, focusing on basic and advanced firearms skills. HNT once again attended their annual WSHNA training conference in Reno, NV.

# **Detention**

There were significant staffing changes within the Detention Division in 2018. The Division had received City Council approval the previous year to increase our number of supervisors from two to four to enhance jail supervision. We consequently promoted two Custody Officers to the rank of Custody Sergeants in mid-July of 2018. 2017 left us with several vacancies that we were able to fill by hiring six custody officers.



#### **ACTIVITIES AND ACCOMPLISHMENTS**

The Lynnwood Jail houses arrested and sentenced misdemeanor offenders for the City of Lynnwood and several local contract agencies. The jail continued to operate at or near maximum capacity throughout the year. The maximum number of jail beds is 12 for females and 34 for males, totaling 46.

The Detention Division also provided full-time security services to the Lynnwood Municipal Court for most of the year. However, in August of 2018, court security services became a shared responsibility of both detention and police personnel.

# CUSTODY OFFICERS PERFORMED OVER

The Lynnwood Jail identifies prisoners with certain medical, behavioral or psychiatric needs. Some of these inmates are housed at contract jails for their health and safety. In late 2013, a contract was established with the SCORE (South Correctional Entity) Jail to accommodate some inmates.

In addition to SCORE, the Lynnwood Jail also maintains housing contracts with Yakima County Jail and Sunnyside Jail to facilitate the housing of inmates with longer sentences at a reduced rate. Additionally, Yakima County Jail has the ability to manage inmates with some medical or mental health needs. The Lynnwood Jail also maintains a contract with the Snohomish County Jail.

Management and staff at the Lynnwood Jail with cooperation from the Municipal Court, Public Defender, and Prosecutor's Office, work hard to efficiently and cost-effectively house inmates sentenced for offenses committed in the City.

#### **JAIL MEDICAL PROGRAM**

In mid-2015 we implemented the Lynnwood Jail Medical Program. The City of Lynnwood has utilized a contract medical service provider to provide medical service for the inmates. Currently a nurse works five days a week with no more than one day off between shifts. The program is monitored by an assigned physician who visits weekly.

The nurse reviews newly arrived inmate screening documents, answers inmate medical requests, conducts additional screening on inmates housed



over 14 days, and reviews and prepares inmate prescriptions.

Our nurses are a vital part of the Detention Division. Their contributions have enhanced the health and safety of the inmates within the Jail, who are frequently members of the Lynnwood community.

# ELECTRONIC HOME DETENTION AND COMMUNITY SERVICE PROGRAMS



The Electronic Home Detention (EHD) program is an alternative to physical incarceration and is available to most low-level offenders. Typically, the program is managed by one designated custody officer. EHD participants pay a daily fee to be on the program and are monitored through a variety of sophisticated technologies. This allows offenders to stay at home or remain active with employment, education or treatment as ordered by the Court, while serving their sentence. Economic factors, as well as the reduction in sentences from the Lynwood Municipal also contributed to program activity Court, reductions. Despite these significant challenges, the EHD program remains an integral component to controlling jail population.

Unfortunately, because of unanticipated staffing shortages, the EHD program was outsourced during 2018. While the alternative for home detention still

existed for those wishing to apply, they were referred to private companies rather than being monitored by the Lynnwood Jail EHD officer.

The Community Service Program, like EHD, continued to be a valuable incarceration alternative for the City. This program provides an inexpensive and meaningful alternative to traditional incarceration for offenders who qualify and who have shorter sentences to serve. The Police, Parks, Public Works and other community development departments and programs benefited from work provided by these low-level offenders. The Lynnwood Food Bank and the Public Library were also aided by services provided by the program.

#### VIDEO COURT SERVICES

The Lynnwood Jail continued to utilize video court services at the SCORE Jail for inmates housed that had pending Lynnwood Municipal Court cases. This greatly reduces the need for prisoner transports which enhances both inmate and officer safety as well as staff time for transport.

#### **COMMUNITY OUTREACH**

Several custody officers participated with the annual Christmas "Shop with a Cop" program, the "Cops & Kids" event, the Lynnwood Police Explorer Post, Coffee with a Cop, Special Olympics, and other community events.

Detention Division personnel presented information to the public through our Citizen's Academy and Lynnwood University. Attendees were able to tour the jail and sample meals provided to inmates.

# JUVENILE HOLDING SITE INSPECTION/AUDIT:

The Detention Division processed 56 juvenile

arrestees during 2018 and provided reports to the Office of Juvenile Justice regarding those holds. As we do annually, the Lynnwood Jail was inspected by an outside agency in 2018 to




see where we can improve and help identify inefficiencies.

# Investigations

The Criminal Investigations Division (CID) is the investigative arm of the police department. Every criminal case report is reviewed by one of two CID sergeants, who determine if there are solvability factors. If there are, the case is assigned to a detective for investigation, except in the case of misdemeanor property crimes, which are sometimes assigned to Patrol, Traffic, or the Special Operations section.

#### **NOTEWORTHY EVENTS**

The Lynnwood Police Department responded to a female suffering from mental illness who was walking down the street with a firearm, firing into the air several times. She was taken into custody without incident. Detectives followed up with what would be our first use of a new law granting an Extreme Risk Protection Order (ERPO) (RCW 7.94) An



(ERPO) is a court order that temporarily suspends a person's right to possess firearms if there is evidence that the person is threatening to harm him or herself or others. Detectives successfully obtained this court order, removed her weapons, and advised her of the prohibition for her to possess firearms.

In late summer, officers responded to a call involving persons shot at Lynndale Park in the early morning hours. As officers and detectives worked to understand what occurred, another shooting occurred north of the original incident. A man searching for his dog with his sister was fired upon and shot by unknown motorists he had observed near house in Lynnwood. Subsequent investigations yielded the arrest of two subjects for the original shooting, one of whom was tied via a firearm to several other shootings and robberies in greater south Snohomish County during the months. Additionally, detectives preceding conducting surveillance of the house where the second shooting was believed to have originated, observed additional suspects arrive, park, retrieve a gun from their vehicle, and proceed inside. That house was surrounded and North Sound Metro **SWAT** Several was called. subjects arrested and another handgun was recovered during a thorough search.

In late 2018, an unknown student threatened via Snapchat to "shoot up" Meadowdale Middle School

the following day. Detectives worked diligently to identify the suspect amidst the growing concern of school officials and parents. Detectives were able to quickly gather enough information through requests to Snapchat and other methods to identify the juvenile student responsible. Lynnwood Police personnel quickly responded to this juvenile's house, informed the juvenile's parents, contacted the juvenile who confessed, searched the residence and notified school officials and parents alike.

## CID Made 208 Arrests in 2018

The City of Lynnwood is a retail hub within Snohomish County and is home to hundreds of licensed businesses. Unfortunately, some of these businesses have suffered losses through theft or fraud. We work with our business owners in an attempt to decrease theft incidents and to recover property when possible. Our crime scene technicians process evidence related to many theft cases to hold offenders accountable.

#### VALUE OF STOLEN RETAIL PROPERTY BY YEAR




Chart represents retail sales theft for 2016—2018 and does not include vehicle thefts.

# Special Operations Section

The Special Operations Section (SOS) conducts street -level criminal investigations with a focus on identifying serious criminal activity. SOS works collaboratively with Patrol, Investigations, and our Community Health and Safety Section in their tenacious pursuit of criminals who seek to do harm to our community.

SOS maintains strong ties with the regional drug task force as well as federal law enforcement agencies. SOS performed exceptionally well during 2018 despite the fact that for most of the year it was operating at half of its authorized staffing.

SOS enhanced gang and criminal intelligence, drug trafficking investigations, collaboration with City and departmental units, and further developed operational relationships with local, State and Federal law enforcement partners.

#### **NOTEWORTHY EVENTS**

SOS assisted the Department of Corrections (DOC) with contacting a supervised person. DOC had received information the subject possibly had a firearm in the residence. DOC detained the subject and SOS assisted in the search. Three firearms and crack cocaine were located in the residence. The subject is a multiple time convicted felon with two Robbery 1 and two Robbery 2 convictions. One of the firearms was listed as stolen out of King County.

SOS, CID, Patrol and SWAT performed several search warrants on a residence. Several subjects were placed into custody including a convicted felon. One shotgun and three rifles were located in the residence and in an associated vehicle. 96.51 grams of Methamphetamine and 190.04 grams of Heroin were located in a bedroom. Three stolen motorcycles, a stolen bicycle and a stolen snowmobile were recovered as well.



## **Victim Services**

The Victim Services Coordinator serves as the liaison between crime victims, the prosecutor's office, and the detectives investigating cases. The Victim Services Coordinator contacts all victims of domestic violence, as well as the victims of other crimes as necessary, to help them navigate the criminal justice system. Additionally, the Victim Services Coordinator provides information on services offered throughout the county and offers a child-friendly environment for victims and their families.



# **Support Services Records**

#### **PERSONNEL**

The Lynnwood Police Department front desk is staffed by our records clerks and open to the public nine hours per day, seven days a week. Authorized staffing consists of one support services manager and seven full-time records clerks.

#### **ACTIVITY**

Because records clerks within the Support Services Division provide direct service at the police station front desk and phone systems, they are often the first contact members of our community have with the Police Department.

The Support Services Division serves as the central repository for all records of the Police Department. The records clerks process police reports, arrest reports, citations, infractions, and collision reports generated from various units within the Department. They also process all requests for concealed pistol licenses, federal firearms licenses, pet licenses, public records requests, and public fingerprinting.

Records clerks provide essential support to our jail by providing female prisoner searches during periods when no female custody officer is on duty.

Two full-time evidence technicians maintain all evidence in criminal cases and provide a secure location for the maintaining of property that is recovered and/or seized by the Lynnwood Police Department. They are charged with preserving the chain of custody of all items from initial receipt to final disposal or release. This includes tracking every item as it is distributed to a variety of state and private labs for testing, out to officers for further examination, or to courts for trial.

# **Administrative**

The Administrative Services Division consists of the Planning, Training, and Accreditation Section; the Office of Professional Standards; the Community Health and Safety Section; the Cadet Program; and oversight of department technologies, equipment. The focus of the division includes recruitment and hiring, policy development and internal affairs and administrative functions. Other responsibilities include managing training for all department staff and ensuring compliance with WASPC Accreditation standards, managing all department equipment and technologies, reporting and analysis of select law enforcement actions. The Administrative Services Division also provides administrative support to the command staff and the Office of the Chief of Police, while ensuring compliance with departmental policies and procedures through ongoing audits and investigations.

# Planning, Training, and Accreditation

The Planning, Training and Accreditation Section provides quality training on all aspects of police work to departmental members and employees. They maintain accurate and up-to-date training records consistent with accreditation standards, maintain departmental technology and equipment, and track expenditures of training funds. The Training Sergeant critically examines all use of force and vehicle pursuit incidents.

In 2018 the Training Section organized, scheduled, and facilitated six sessions of in-house Police Skills Refresher training for all commissioned officers as mandated by law. Each session consisted of 24 hours of training on a variety of topics.

The Training Section supervised twelve new officers while they attended the Washington State Criminal Justice Training Commission Basic Law Enforcement Academy (BLEA), or the Corrections Academy (COA).

Over the course of the year, the training section managed 13,599 hours of training for employees within the department. This included courses such

as de-escalation training for patrol officers, management and liability training, tactics and best practices, firearms, emotional intelligence, basic medical training, and courses to increase organizational efficiency.

Members of the Training Section participated in National Night Out, Shop with a Cop, Cops & Kids, and Citizen's Academy. They also participated in several entry-level oral board processes and completed background investigations for prospective employees.

#### CADET PROGRAM

The Training Section is responsible for managing the Cadet Program. The Department employed three college students on a part-time basis who are interested in the field of criminal justice.

public The cadets conducted scheduled fingerprinting sessions in 2018. They transported evidence to both the State crime labs and the Prosecutors Office, assisted in the upkeep and management of the department's fleet, reprogrammed the department's security door locks throughout the year, transported training equipment and supplies to training locations, assisted in the

maintenance of the police buildings, and were assigned mentor officers whom they rode with while on patrol throughout the year.

They also are involved in re-implementing the Parks Patrol Program in conjunction with the Parks Department. The cadets work on average 8 hours per week and endeavor to visit all of the 16 plus parks within the city. This involves uniformed Cadets on foot patrols within the public parks in Lynnwood throughout the year. Their mission was to be a presence and a set of eyes to report anything that reduced the quality of life for park visitors. This included reporting any in-progress crimes or suspicious activity that may require a police response, notifying the Parks Department of any litter or debris, documenting instances of graffiti, and reporting any suspicious activity to law enforcement. In addition, they served as a resource for park patrons having questions relating to the services within the parks. They are also present to educate park patrons on local ordinances and to generally promote a better park experience for the This endeavor was a partnership community. between the Lynnwood Police Department and the Lynnwood Parks Department.

# Office of Professional Standards

The Office of Professional Standards (OPS) provides essential support services to the Police Department and its personnel by maintaining high standards of ethics and professionalism in the areas of recruitment; pre-employment background investigations and promotional functions. This unit examines departmental policy, performs internal audits of money and evidentiary controls and mechanisms; investigates internal and citizengenerated complaints of alleged misconduct against employees; and performs other projects as directed by the Chief of Police. All services are provided with the utmost integrity, courtesy and operational efficiency.

This office facilitated the hiring process for 14 new hires, which included scheduling and participating in oral boards, scheduling pre-employment screening tests, and conducting or supervising background investigations.

Supporting our core value of Community, OPS organized and participated in the Tip-A-Cop fundraisers with local restaurants in Lynnwood including Red Robin and Claim Jumper raising more than \$5,000 for Special Olympics!

#### **ACCOUNTABILITY**

In 2018, the Police Department received 14 complaints involving department employees. Upon investigation, four of these complaints identified violations of policy or procedures. In those instances, appropriate corrective action and/or training measures were administered.

In 2018, the Police Department did not receive any biased-based (racial profiling) complaints.

# **Community Health** and Safety Section

The Community Health and Safety Section (CHSS) serves to effectively address health and safety needs of the community through collaboration, engagement, and empowerment.

The Community Health and Safety Section is staffed by a sergeant supervising two commissioned CHSS officers, an animal control officer, a social worker, a school resource officer, and two crime prevention specialists.

# INTENTIONAL COMMUNITY ENGAGEMENT & PARTNERSHIPS

During 2018, the Community Health and Safety Section actively sought out innovative outreach opportunities to engage our diverse Lynnwood community. We have created and maintained the following programs to ensure our outreach efforts are meaningful and inclusive: Cops and Clergy, Lynnwood Police Kids Camp, Citizens Academy, Green and Clean neighborhood beautification, Teaching Equity Summit, Shop with a Cop, National Night Out.

Additionally, members of CHSS teamed with Verdant, Swedish Hospital, Edmonds Police Department, and South Snohomish County Fire and Rescue in a collaborative effort known as CHART. The purpose of CHART is to link chronic users of emergency services with the appropriate and effective intensive help while at the same time reducing their impact on these high-cost systems and saving tax payer money.

Additionally, CHSS spent considerable time educating members of our community on safety-related topics. Topics included active shooter, Stop the Bleed, cyber crime awareness, disaster preparedness, and the complexity of addiction and homelessness.

#### **EMBEDDED SOCIAL WORKER**

In collaboration with the Edmonds Police Department, our police social worker forms an outreach team with Community Health and Safety Section police officers to assertively engage our homeless, mentally ill, and substance use affected community members in the field. Our social worker strives to walk alongside community members, connecting them to the appropriate resources based upon their own unique circumstances and needs. The effectiveness of the program relies on the social worker's ability to establish rapport with clients and to build and maintain relationships with community partners and resource providers.




