

#### **CONNECT LYNNWOOD:** Active & Accessible Transportation Plan

- Improvements to walking and bicycling conditions
- Safe access to **schools**, **parks**, and **transit**
- **Safe, efficient** transportation system
- Serve people walking, rolling, driving and taking transit





# **CONNECT LYNNWOOD:** Parks Access Chapter

- Part of a nationwide movement to ensure everyone has access to a high-quality park
- Identifies infrastructure improvements to make trips to parks safe and comfortable for people walking, biking, and rolling







# How did we identify Parks Access improvements?

- Park Champions field work (Spring 2019)
- Existing walking and bicycling conditions analysis from Active & Accessible Transportation Plan
- Applied proven safety countermeasures (also used in School Access and Safety Plans)








# Parks Access Improvements: Guiding Principles

- Start at park entrances and work out within 1/2-mile walkshed
- Focus improvements along and across **difficult-to-cross streets**
- Create **comfortable, familyfriendly bike connections** to parks
- Coordinate with School Access and Safety Plans and focus on areas where park and school walksheds overlap
- Incorporate wayfinding and signage recommendations from park champion field work


#### **Ease of Crossing**





- Missing sidewalks
- Existing or planned bike facilities
- Collisions involving people walking and bicycling







# **TYPES OF IMPROVEMENTS**

- Family-friendly bikeway
  - Sidepath, or protected bike lanes with separation from traffic
- Sidewalk or low-cost walking improvements (sidewalk alternative on residential streets)

#### • Enhanced crossing

- Could include marked crosswalk, signage, curb extension, median crossing island, or flashing beacon
- Pedestrian over/undercrossing
- Trail connection
- Signage and wayfinding
