SUBMITTAL OF SEALED BIDS:

Sealed bid proposals (“Bids”) will be received by the Public Works Deputy Director, or the Public Works Deputy Director’s representative, at Lynnwood City Hall, 19100 44th Avenue W., Lynnwood, Snohomish County, Washington, 98036, until 2:00 p.m., January 9, 2018, for the following project (“Project”):

Interurban Trail Missing Link South Segment

Capitalized terms not defined in this Invitation for Bids shall have the meanings set forth in the Project Manual of which this Invitation for Bids is a part.

BID OPENING:

At the time and date above stated, the Bids will be publicly opened and read aloud (“Bid Opening”). Bids are to be submitted only on the bid proposal forms provided with the Project Manual. All Bids must be accompanied by a bid bond, cashier’s check, certified check, or postal money order in an amount not less than five (5) percent of the total amount of the Bid. Bids received after the time fixed for the Bid Opening will not be considered.

DESCRIPTION OF WORK:

The current Interurban Trail route is routed along 212th Street SW, 63rd Avenue W, 211th Street SW and up to 61st Avenue W and through South Lynnwood Neighborhood Park. The proposed Project includes rerouting the trail alignment along 212th Street SW to the east and then north through the Snohomish County PUD right of way and connect to the existing trail to the north. The project also includes sewer and storm drain utility replacement, surface grading, signage, and curbs along 212th Street SW.

All Bids shall be based upon compliance with the Project Manual (including, without limitation, the Contract Plans and Specifications). The estimated cost range for this project is \$1,500,00.00 to \$1,800,000.00. The project shall be Physically Completed within in 160 days of the Notice to Proceed.

OBTAINING BID DOCUMENTS:

The City expressly reserves the right to reject any or all Bids, to waive irregularities, and to award the Project to the lowest responsive, responsible Bidder.

No Bidder may withdraw its Bid within forty-five (45) days after the actual date of the Bid Opening.
