SUBMITTAL OF SEALED BIDS:

Sealed bid proposals (“Bids”) will be received by the Public Works Deputy Director, or the Public Works Deputy Director’s representative, at Lynnwood City Hall, 19100 44th Avenue W., Lynnwood, Snohomish County, Washington, 98036, until 2:00 p.m., February 28, 2018, for the following project (“Project”):

36th Avenue W Corridor Improvements Project

Capitalized terms not defined in this Invitation for Bids shall have the meanings set forth in the Project Manual of which this Invitation for Bids is a part.

BID OPENING:

At the time and date above stated, the Bids will be publicly opened and read aloud (“Bid Opening”). Bids are to be submitted only on the bid proposal forms provided with the Project Manual. All Bids must be accompanied by a bid bond, cashier's check, certified check, or postal money order in an amount not less than five (5) percent of the total amount of the Bid. Bids received after the time fixed for the Bid Opening will not be considered.

DESCRIPTION OF WORK:

This Contract provides for the improvement of 36th Avenue West between 180th Place SW and 165th Place SW. The Work includes but is not limited to: select demolition and removal; rehabilitation of the roadway using the full depth reclamation approach and hot mix asphalt; construction of cement concrete sidewalks, curb ramps, curbs and gutters, stormwater systems and detention tanks, block retaining walls, soldier pile retaining walls, a new traffic signal system at the intersection of 36 Avenue West and Maple Road/179th Street SW and other electrical appurtenances including a service cabinet, electrical lines and junction boxes, a new roundabout at the intersection of 36th Avenue West and 172th Street SW, pavement markings, traffic control, landscaping, wetland mitigation, property restoration, and other miscellaneous work.

All Bids shall be based upon compliance with the Project Manual (including, without limitation, the Contract Plans and Specifications). The estimated cost range for this project is (\$8,500,000 to \$9,500,000). The project shall be Physically Completed within 460 working days of the Notice to Proceed.

The Project Manual for this Project (including the Contract Plans, Specifications and all other Contract Documents) may be examined at the Lynnwood City Hall.
